TITLE: Quasi-Judicial/Public Hearing/Resolution granting a Waiver of Limitations
for John C. Jr. & Cheryl J. Gorman / 720 NE 20th Ave. via ULDR Sections
C, D and E.

Recommendation

It is recommended that the City Commission adopt a resolution granting a waiver of limitations for (i) lateral relocation of two (2) of three (3) existing triple pile clusters, (ii) the installation of a ten (10) foot extension to an existing finger pier, and (iii) the installation of three (3) triple-pile clusters for John C. Jr. & Cheryl J Gorman, 720 NE 20th Ave.

Background

The applicant is seeking a resolution granting a waiver of limitations (a waiver to allow a dock and mooring structure, to extend beyond the maximum distance as defined by City Code) of the Unified Land and Development Regulations (ULDR) Sec 47-19.3 C and D for (i) the lateral relocation of two (2) of three (3) existing triple-pile clusters, (ii) the installation of a 10 foot extension to an existing finger pier, and (iii) the installation of three (3) triple-pile clusters extending a maximum of 125 feet from the property line into the Middle River. Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$300.00 is required. The applicant's narrative specifies that the additional distance for these mooring structures is necessary for safely mooring existing vessels as well as the extraordinary width of the waterway at this location.

The Marine Advisory Board recommended approval of the application unanimously 12:0 (see **Exhibit 3**).

Resource Impact

There is a positive fiscal impact in the amount of \$300.
