Dear Mr. Minney:

Please consider this letter a request for County FTA Grant and Community Bus funds for fiscal year 2012-13 for the Downtown Fort Lauderdale Transportation Management Association (TMA) Sun Trolley.

County FTA Funds:

In order to expand the Beach Link route from 4-day to 7-day per week service and increase the hourly draw down rate from \$11.97 to \$15.04, the City is requesting an additional \$62,536.32 in County FTA grant funds. This additional \$62,536.32 added to the current \$84,464.64, totals \$147,000.96 requested for the Beach Link route.

Additionally, the City is requesting a similar hourly rate increase in County FTA Grant funds for the Galt Link route. The City is requesting \$12,722.08 in addition to the current draw down amount \$49,603.68 for a new request of \$62,325.76 for the Galt Link route. Together with the \$147,000.96 from the Beach Link route, the total request for County FTA Grant funds is \$209,326.72 for FY 2012-13.

Community Bus Funds:

Due to the increase of service days on the Beach Link, the City is requesting an additional \$62,370 in Community Bus funds. That added to the existing \$242,342.25 totals \$304,712.25 in Community Bus funds requested for FY 2012-13.

Therefore, the City of Fort Lauderdale is requesting:
