***Infrastructure Task Force Advisory Committee (ITFAC)  
August 5, 2024***

Mayor Trantalis read the ITFAC's Communication to the Commission. In response to Mayor Trantalis' question, Acting City Manager Susan Grant confirmed that \$3,000,000 was allocated in the Fiscal Year 2025 Water and Sewer Budget for updating the Utility Strategic Master Plan.

***Historic Preservation Board (HPB)  
August 5, 2024***

Mayor Trantalis read the HPB's Communication to the Commission. Mayor Trantalis said that Broward County (County) owns the Broward Addiction and Recovery Center (BARC) Site and that Staff would pass the recommendation on to the County. Mayor Trantalis remarked on his understanding of the County's plans for the site.

Mayor Trantalis remarked that additional information regarding the HPB recommendation to relocate historic homes would be distributed to

Commission Members and requested they review and provide their input.

***Fire Rescue Advisory Committee (FRAC)  
August 12, 2024***

Mayor Trantalis read the FRAC's Communication to the Commission and said that the recommendation had been fulfilled.

**OLD/NEW BUSINESS**

**BUS-1 [24-0777](#)**

Broward Sierra Group - Junior Team and the Cortada Foundation to present, *The Underwater* - (Commission Districts 1, 2, 3 and 4)

Mayor Trantalis recognized Elisa Jones, Vice Chair of the Broward Sierra Group. Ms. Jones read from a prepared statement discussing the history, purpose, and goals of the Sierra Group's Junior Team, a group of high school students working to preserve the environment through advocacy, outreach, and education, including supporting environmentally conscious political candidates' efforts to address environmental issues and climate change. Ms. Jones requested the Commission's support to bring the Sierra Group's Junior Team's initiative to Broward County (County) High Schools and Middle Schools.

Mayor Trantalis recognized Adam Roberti, Executive Director of the Xavier Cortada Foundation. Mr. Roberti narrated a presentation entitled *The Underwater, A Socially Engaged Art Project by Xavier Cortada (The Underwater)*.

In response to Commissioner Sturman's question, Mr. Roberti explained that the artwork's elevation numerals and corresponding location throughout Broward County indicate future water level heights from sea level rise and explained related information. Mr. Roberti expounded on the efforts of *The Underwater* initiative illustrated in the presentation and its goals to involve schools, local governments, and the community to take action to address rising sea levels.

In response to Mayor Trantalis' question, Mr. Roberti explained aspects

of the initiative and efforts to combat climate change, including transitioning to renewable, non-fossil fuel energy as soon as possible to reduce greenhouse gas emissions. Mr. Roberti expounded on related information.

Vice Mayor Glassman acknowledged the efforts of this initiative and expounded on his support and experience with the Sierra Group's efforts. He discussed including this information in his District 2 communications to the community and local schools. Mayor Trantalis acknowledged and commented on his support of the initiative's efforts. Further comment and discussion ensued.

**BUS-2** [24-0833](#)

Update - Prospect Lake Clean Water Center - (Commission Districts 1, 2, 3, and 4)

Mayor Trantalis recognized Alan Dodd, Public Works Department Director. Mr. Dodd provided an overview of this Agenda item and confirmed the goal of the Prospect Lake Clean Water Center (PLCW Center) being fully operational in September 2026.

Mayor Trantalis recognized Mark Janay, Operating Partner of Ridgewood Infrastructure. Mr. Janay commented on this Agenda item and introduced Joseph Padrone, Vice President of the PLCW Center. Mr. Padrone provided an update on the construction of the PLCW Center, narrating a presentation entitled *Prospect Lake Clean Water Center*.

***A copy of the presentation is part of the backup to this Agenda item.***

Mr. Dodd narrated the Optimal Corrosion Control Treatment Plan portion of the presentation.

In response to Mayor Trantalis' questions regarding a photo in the presentation, Mr. Dodd explained it illustrates a metal water distribution pipe with severe corrosion buildup over several years and expounded on related information.

In response to Commissioner Sturman's questions, Mr. Dodd said that water transmission from the PLCW Center would travel to the Fiveash Plant for distribution to residents and businesses. Mr. Dodd provided an update on the age and condition of pipes leaving Fiveash for distribution to the City that need to be addressed. Commissioner Sturman remarked on the need to consider that concern.

Mr. Janay continued narrating the presentation, which included an update on PFAS and ensuring compliance with recently enacted Environmental Protection Agency (EPA) PFAS regulations.

Mayor Trantalis noted his understanding that EPA PFAS regulations were not in effect when the PLCW Center Comprehensive Agreement was executed and that an upcoming Change Order would address recently enacted EPA regulations. Mr. Janay confirmed and explained plans for testing that would indicate necessary modifications when the PLCW Center is online. Mr. Janay noted the EPA's 2029 deadline to comply with the PFAS level requirements.

Mayor Trantalis remarked on the need for compliance and inquired about PFAS levels at the Peele Dixie Water Treatment Plant. Mr. Dodd said those PFAS levels are below the EPA's acceptable levels due to the water source and processing, which is one hundred percent (100%) nano-filtering. Mr. Dodd explained related information.

In response to Commissioner Herbst's question, Mr. Dodd explained that the Peele Dixie Water Plant was retrofitted with nano-filtering technology. The water filtration equipment at the PLCW Center will be seventy percent (70%) nano-technology and thirty percent (30%) ion-filtration technology.

Mayor Trantalis remarked on the need to comply with EPA PFAS requirements as soon as possible. Acting City Manager Grant confirmed that a fund had been incorporated into the PLCW Center budget to address those types of unknown factors. Commissioner Sturman discussed his recollection of Commission decisions that included plans to address those types of issues and expounded on his viewpoint. Mr. Dodd confirmed and clarified that the contaminants discussed relate to pretreated water quality, not water delivered to City residents and businesses. Commissioner Sturman remarked on a past concern about the color of the Peele Dixie Plant and expounded on related information.

Mr. Dodd continued the presentation regarding upcoming Change Orders.

Mayor Trantalis noted his understanding of the enabling works. Mr. Dodd clarified that the \$181,000,000 in enabling works was for pipes transporting water from the well fields into the PLCW Center and explained related information. Further comment and discussion ensued.

In response to Commissioner Sturman's question, Mr. Dodd reiterated

the difference between the water filtration at Peele Dixie Water Treatment Plant and the PLCW Center. He explained that this was due to the consumption permit limits associated with the amount of water allowed to be drawn from the Biscayne Aquifer and commented on related information. Further comment and discussion ensued.

In response to Mayor Trantalis' question regarding the start date for using the PLCW Center, Mr. Dodd confirmed September 2026 as the anticipated start date.

### CONFERENCE REPORTS

City Homeless Initiatives Update - (Commission Districts 1, 2, 3 and 4)

Commissioner Sturman provided an overview of homeless initiative efforts and remarked on related discussions with Broward County Board of County Commissioner Lamar Fisher and the understanding that all Broward County (County) municipalities would be responsible for addressing homelessness.

Mayor Trantalis recognized Chris Cooper, Acting Assistant City Manager. Mr. Cooper provided an overview of this Agenda item and introduced Luisa Agathon, Neighborhood Support Manager. Ms. Agathon narrated a presentation entitled *City Homeless Initiatives Update*.

***A copy of the presentation is part of the backup to this Agenda item.***

In response to Commissioner Sturman's question, Ms. Agathon confirmed the number of the Voices in the Street count listed in the slide. Commissioner Sturman commented that the number aligns with the 2023 Point in Time (PIT) count.

In response to Commissioner Beasley-Pittman's question, Ms. Agathon confirmed the PIT count consists of homeless individuals who had agreed to be identified.

In response to Commissioner Sturman's question, Ms. Agathon confirmed the total number of available shelter beds paid for by the County and the number of shelter bed capacity listed in the presentation. Further comment and discussion ensued regarding homelessness shelters operating close to and below capacity. Ms. Agathon confirmed the amounts listed in the presentation illustrate the per-day cost of

providing a shelter bed.

In response to Mayor Trantalis' question, Ms. Agathon explained that the data in the presentation represents shelters funded by the County. She confirmed other types of available housing, including transitional housing provided by the Salvation Army and vouchers for permanent supportive housing. The beds listed in the presentation represent immediate overnight emergency housing for people experiencing homelessness.

In response to Commissioner Sturman's question, Ms. Agathon confirmed substance abuse treatment includes alcohol.

In response to Commissioner Herbst's questions, Ms. Agathon explained information related to referrals listed in the presentation. Individuals are connected to the service provider or non-profit organization that provides the respective type of service. The housing referral number indicates the number of individuals that the Task Force connected to emergency shelter beds or assisted with paperwork for placement on the permanent housing list. Further comment and discussion ensued regarding outcomes for substance abuse referrals listed in the presentation.

Commissioner Herbst remarked on concerns regarding measuring efforts, recommended Staff measure the performance outcomes of referrals, and expounded on his viewpoint. Mayor Trantalis concurred with Commissioner Herbst's remarks and discussed his perspective. Ms. Agathon explained information related to decisions made by the Community Court Judge that impact measurements and cited examples. Further comment and discussion ensued.

Commissioner Sturman remarked on the difficulty of quantifying performance measurements and cited examples related to addiction. Commissioner Herbst remarked on his experience in quantifying performance outcomes to determine the efficacy of programs, and cited examples. Further comment and discussion ensued. Commissioner Herbst noted the need for accurate measurements to determine the effective use of funding.

In response to Mayor Trantalis' question, Commissioner Sturman explained his viewpoint regarding defining success and cited examples. Commissioner Herbst remarked on his perspective regarding the need to define success, recommended discussing this concern with professional experts and commented on funding.

Commissioner Sturman commented on limited resources, discussed

related information, and noted the need to achieve the best results with allocated funding. Mr. Cooper agreed on the need for improved performance measurements, expounded on Staff efforts, and cited examples.

Vice Mayor Glassman noted the multiple government agencies contributing towards this effort and inquired about related benchmarks and performance measurements. In response to Vice Mayor Glassman's question, Mr. Cooper explained information associated with tracking funding from the Broward County Continuum of Care, State and federal grants, other County-funded programs, and efforts of non-profit organizations. Mr. Cooper remarked on information related to the flow of funding to agencies and service providers. Further comment and discussion ensued.

Commissioner Sturman remarked on his understanding of City and County funding.

In response to Mayor Trantalis' question, Ms. Agathon commented on Park Ranger checks that monitor homelessness in City Parks. Park Ranger rounds provide related reports but do not involve encounters with individuals experiencing homelessness.

In response to Commissioner Sturman's questions, Ms. Agathon explained information associated with Park Ranger staffing and related Staff Police Department efforts to address homelessness.

In response to Mayor Trantalis' question, Ms. Agathon discussed the difference between the number of individual housing referrals and the number of individuals on the housing list. Mayor Trantalis remarked on the significant difference and expounded on his perspective. Ms. Agathon clarified the efforts and details of the housing referral program. Mayor Trantalis remarked on the lack of adequate capacity to address the number of individuals experiencing homelessness in the City. Mayor Trantalis recommended that Staff determine solutions and expounded on his perspective. Further comment and discussion ensued.

In response to Mayor Trantalis' questions, Ms. Agathon noted that some individuals experiencing homelessness refuse to participate in the availability of shelter beds and are subsequently released. Mr. Cooper confirmed these programs are voluntary and commented on related information. Further comment and discussion ensued.

Mr. Cooper continued narrating the presentation, which focused on the



City's response and coordination to House Bill 1365, Unauthorized Public Camping and Public Sleeping (H.B. 1365).

In response to Commissioner Beasley-Pittman's questions, Mr. Cooper explained available technology options for reporting violations of H.B. 1365 that go directly to Neighbor Support Staff. Acting City Manager Grant explained there would be Staff training for Neighbor Support Staff to reroute reports of those activities to the City's application/website to ensure all information is centralized. Mr. Cooper remarked on the need for an ordinance to address the submission of a written complaint of unauthorized activity that would be rerouted to the application/website. Acting City Manager Grant confirmed additional Staff would be added to address routing and measuring performance.

In response to Mayor Trantalis' question, Mr. Cooper confirmed grant funding to secure additional beds at existing providers, ten (10) for mental health and ten (10) for substance abuse included in the presentation. Further comment and discussion ensued.

In response to Mayor Trantalis' question, Mr. Cooper explained County efforts and expounded on related information, including working with the County to pursue pallet homes and continuing to grow affordable housing opportunities.

Commissioner Beasley-Pittman remarked on concerns regarding using Northwest-Progresso-Flagler Heights Community Redevelopment Agency (NWPFH CRA) funds to purchase the building located at 18 NW 1st Avenue for Community Court. In response to Mayor Trantalis' question, Mr. Cooper confirmed that the requested funding from the NWPFH CRA is \$3,000,000 and commented on related information. Further comment and discussion ensued regarding the proximity of Community Court to residential units and finding a new location for Hope South Florida to provide their services.

In response to Vice Mayor Glassman's questions, Mr. Cooper provided the square footage of the building and commented on the ability to provide additional services. Vice Mayor Glassman reiterated the need to find a location for Hope South Florida services that is not adjacent to a residential neighborhood.

Commissioner Beasley-Pittman discussed the anticipated life of the building. She commented on concerns related to using \$3,000,000 from the NWPFH CRA and its impact on the progress of the Sistrunk Boulevard area. Further comment and discussion ensued regarding the

option of renting space in the building versus purchasing.

Commissioner Herbst discussed the NWPFH CRA sunseting in November 2025 and related options available to the Commission that have not been decided.

Mayor Trantalis described the interior of the building, commented on his perspective regarding programming its existing space and the cost, remarked on related information, and requested a recommendation from Staff.

Mayor Trantalis recognized Assistant City Manager Anthony Fajardo. Mr. Fajardo provided an overview of Staff's presentation to the CRA Board that included the five (5) year base rent range for renting the building, estimated between \$1,100,000 and \$1,500,000 that would be generated to the controlling entity depending upon Commission action to extend the NWPFH CRA. Mr. Fajardo explained related information.

Commissioner Herbst remarked on his understanding of details related to the Commission's decision on this topic. Mr. Fajardo confirmed. Commissioner Herbst discussed a similar situation in the past and remarked on considerations regarding the cost of purchasing the building for Community Court needs and the need for renovations. He discussed his perspective and support of Community Court and remarked on questions related to best meeting the needs of Community Court.

Mayor Trantalis remarked on his viewpoint regarding finding an alternative location for providing services for the homeless population. Further comment and discussion ensued. Acting City Manager Grant confirmed Staff would provide a related analysis to facilitate a Commission decision. Mr. Fajardo remarked on Community Court location considerations and explained related details. Commissioner Herbst commented on previous efforts related to a homeless feeding program. Mayor Trantalis discussed the need for a centralized location, cited related benefits, and expounded on his perspective.

In response to Commissioner Herbst's question regarding utilizing the Community Court location for a centralized feeding location, Mr. Fajardo noted it was an option. Commissioner Herbst elaborated on discussions with business owners around Stranahan Park and the Broward County Library. Mayor Trantalis confirmed the need for feedback from residents in the area.

In response to Vice Mayor Glassman's question regarding needs in the area around Stranahan Park and the Broward County Library, Acting City Manager Grant confirmed this topic would be included in upcoming discussions with County Staff. Further comment and discussion ensued.

Mayor Trantalis recognized Ted Inserra, 912 SW 19th Street, River Oaks Civic Association President. Mr. Inserra discussed his viewpoint regarding this Agenda item.

Mayor Trantalis recognized Charles King, 105 N. Victoria Park Road. Mr. King discussed his viewpoint on this Agenda item.

Mayor Trantalis recognized Norby Belz, 3333 NW 32nd Avenue, and Vice President of the North Beach Restaurant and Shoppes Business Association. Mr. Belz discussed his viewpoint regarding this Agenda item.

Commissioner Sturman confirmed his support of purchasing the building for Community Court and expounded on his viewpoint. In response to Commissioner Sturman's question, Mr. Cooper explained his understanding of efforts of non-profit organizations to increase the number of shelter beds for people experiencing homelessness.

Commissioner Sturman discussed his perspective regarding short and long-term solutions, Staff recommendations, and his understanding of non-profit efforts to increase shelter bed capacity.

In response to Commissioner Sturman's question, Mr. Cooper commented on the options to provide shipping container homes as an alternative to pallet homes for individuals experiencing homelessness. Commissioner Sturman remarked on the need to determine a location in the City or the County. Further comment and discussion ensued.

In response to Commissioner Sturman's question, Acting City Manager Grant discussed options available through the City's vendor AshBritt for emergency respite beds. Commissioner Sturman commented on this option and the connection to Community Court services for people experiencing homelessness.

Commissioner Sturman noted challenges related to costs, discussed his support of items included in Staff's plan of action, and requested Staff provide a related cost analysis. Mr. Cooper noted the need for Commission direction.

Commissioner Beasley-Pittman noted she was not opposed to purchasing the building for Community Court and providing for the needs of people experiencing homelessness but requested further discussion regarding funding. She remarked on ongoing needs in the NWPFH CRA.

Mayor Trantalis discussed his perspective and the need to respond to H.B. 1365 and cited the proposed ordinance included on tonight's Regular Meeting Agenda that will assist in the City's efforts. He discussed a centralized location and concerns about using the Broward County Stockade, which requires significant renovations. He commented on using the Broadview location in an unincorporated area of the County for pallet homes and the option of utilizing AshBritt's services to provide short-term shelter beds for individuals experiencing homelessness. Mayor Trantalis confirmed he forwarded these options to Broward County Staff but has not received a response.

Mayor Trantalis said that homelessness should not be criminalized and discussed providing immediate shelter relief separate from the County Jail. He remarked on the benefits of centralized social services and expounded on his viewpoint regarding providing Commission direction to Staff to address the H.B. 1365 mandate.

Commissioner Herbst commented on a conversation with Broward County Sheriff Gregory Tony regarding Sheriff Tony's opposition to the use of the County Stockade to house people experiencing homelessness in pallet homes. Commissioner Herbst discussed Sheriff Tony's recommendation to use the Stockade as an intake center for individuals experiencing homelessness and representatives of Broward Health participating in the intake process. Commissioner Herbst acknowledged the need to refurbish the Stockade and funding by the County.

Mayor Trantalis remarked on his viewpoint regarding Sheriff Tony's recommendation and expounded on his perspective. Further comment and discussion ensued. Commissioner Herbst confirmed the need for all stakeholders to address the H.B. 1365 mandate and discussed related information. Commissioner Herbst commented on opposition from the Broadview neighborhood regarding using that area for people experiencing homelessness and cited a related example. Mayor Trantalis remarked on his perspective and noted past efforts to work with the County to address homelessness. Further comment and discussion ensued.

Commissioner Herbst remarked on the need for County approval to provide services in the Broadview neighborhood. Acting City Manager

Grant said that Staff is vetting all possible solutions.

Commissioner Sturman discussed Broward Health's willingness to participate in the intake process at the Stockade. He remarked on his support of the \$3,000,000 purchase of the building for Community Court and said that discussions regarding using the Stockade should continue.

Vice Mayor Glassman requested that Staff present the opportunity to purchase the building for Community Court to the Flagler Village Civic Association prior to proceeding with that option. Further comment and discussion ensued.

### **CITY COMMISSION REPORTS**

#### ***Members of the Commission announced recent and upcoming events.***

Commissioner Beasley-Pittman discussed attending the Broward League of Cities Board Meeting where she discussed the need to adhere to requirements of H.B. 1365 and that all County municipalities should work together to meet the State mandate.

Commissioner Beasley-Pittman noted that Fleet Week is returning to the City and commented on her attendance at the Fleet Week Community Kickoff.

Commissioner Beasley-Pittman remarked on concerns raised by the Rock Island neighborhood, including trash collection, loud music from buildings that violate the Noise Ordinance, needed lighting improvements to address safety concerns, and illegal activity in alleyways. Commissioner Beasley-Pittman encouraged residents to report concerns to the City's Customer Service Phone Line to establish a database.

Commissioner Beasley-Pittman requested that Staff address roadway repairs along Sistrunk Boulevard resulting from infrastructure projects. New pavers were installed on Sistrunk Boulevard before the infrastructure work, and the pavers need to be reinstalled. Commissioner Beasley-Pittman confirmed the need for improved coordination from Staff. Further comment and discussion ensued. Acting City Manager Grant commented on details regarding the source of funding for the initial pavers and said she would provide an update regarding those costs.

Commissioner Beasley-Pittman remarked on issues related to stormwater projects in District 3 that involve contractors who store

infrastructure equipment on private property, and cited examples. In response to Commissioner Beasley-Pittman's question, Acting City Manager Grant confirmed that vendors should contract with private property owners for storage. Staff will contact the Project Manager to rectify those concerns.

Vice Mayor Glassman acknowledged the Victoria Park Civic Association and the Council of Fort Lauderdale Civic Associations for hosting election candidate forums.

Vice Mayor Glassman commented on negative community feedback regarding the One-Way Pairing Study for Andrews Avenue and Third Avenue. He commented on a recent public meeting and requested that Staff monitor resident input and keep the Commission updated on feedback received.

Vice Mayor Glassman commented on a recent Bahia Mar Marina Village ribbon cutting and remarked on related progress at Bahia Mar. He confirmed the need for security at the adjacent parking lot and discussed related needs. Further comment and discussion ensued. Acting City Manager Grant explained associated efforts in coordination with the Florida Department of Transportation (FDOT) to address safety needs in this area of State Road A1A.

Vice Mayor Glassman acknowledged the efforts and contributions of the Police Department and Blue Line Solutions for the successful Back-To-School Event for Northside Elementary that provided needed school supplies to students and the school.

Vice Mayor Glassman acknowledged the efforts of the South Middle River Civic Association and the Police Department that held a Front Porch Roll Call Event in appreciation of Police Officers. Vice Mayor Glassman remarked on the New River Business Exchange and his attendance at a recent meeting.

Vice Mayor Glassman remarked on the need for improvements to Staff's scheduling of important community meetings and events that conflict and requested improved coordination going forward. Further comment and discussion ensued.

Mayor Trantalis commented on the community's participation in the September 11th Recognition Ceremony and thanked the City's First Responders who work every day to keep the community safe.

Mayor Trantalis remarked on attending an event at The Parker where a Flag Exchange took place with the City of Wako and noted his hopefulness that a Sister Cities Program could be established.

### CITY MANAGER REPORTS

City Commission Follow-Up Action Items - (Commission Districts 1, 2, 3 and 4)

Mayor Trantalis recognized Acting City Manager Susan Grant. She remarked on ongoing negotiations with the Broward Hospital District regarding Dottie Mancini Park and said she remains optimistic.
