City Clerk Soloman read the names of the Board and Committee nominees for appointment and/or reappointment at the Commission Regular Meeting on May 6, 2025.

City Clerk Soloman read the names of the Board and Committee appointments and reappointments for Agenda item R-1 into the record.

City Clerk Soloman announced an additional nomination for tonight's Resolution, which was received after the Agenda was published.

Commissioner Glassman discussed his objection to John Rodstrom's nomination to the Planning and Zoning Board and discussed Mr. Rodstrom acting as a lobbyist and participating in previous Commission candidate campaigns.

Vice Mayor Herbst responded to Commissioner Glassman's comments, expounded on his opposing viewpoint, discussed examples, explained related information, and noted that codes of conduct do not apply to individuals prior to being nominated and appointed to Advisory Boards and Advisory Committees. Vice Mayor Herbst clarified that under the First Amendment, individuals are allowed to criticize government, including commenting on social media, and noted that lobbyists are currently serving on Boards. Vice Mayor Herbst reiterated that Commission Members should respect other Commission Members' choices for Board nominations.

In response to Commissioner Sorensen's question, Interim City Attorney D'Wayne Spence confirmed his office is working on an Ordinance that would regulate lobbyist appointments to Boards and Committees. Commissioner Sorensen reiterated his viewpoint that lobbyists should not be allowed to serve on Boards and Committees and expounded on his perspective. Further comment and discussion ensued.

In response to Commissioner Beasley-Pittman's question about when the topic of lobbyists became an issue, Mayor Trantalis recalled that it related to a recommendation by the Charter Revision Board. Further comment and discussion ensued.

Interim City Attorney Spence remarked on the Commission's direction and a subsequent memorandum from the Office of the City Attorney. Further comment and discussion ensued.

In response to Vice Mayor Herbst's question, Commissioner Sorensen explained his viewpoint regarding how an ordinance would address lobbyists serving on Boards and Committees.

In response to Vice Mayor Herbst's question, Interim City Attorney Spence explained Staff efforts to develop an ordinance to address lobbyists serving on Boards and Committees based on Broward County's ordinance and remarked on its genesis. Further comment and discussion ensued.

Vice Mayor Herbst remarked on the difference between occasional lobbying efforts when advocating on behalf of individuals with items before the Commission and full-time lobbying activities. Interim City Attorney Spence confirmed both scenarios would constitute lobbying.

Mayor Trantalis recognized Barbra Stern, 1929 NE 1st Avenue. Ms. Stern discussed her viewpoint, and remarked on individuals currently

serving or nominated to Boards and Committees who have lobbied before the Commission. She cited examples of individuals whose careers may be a conflict of interest with future Planning and Zoning Board decisions, and expounded on additional concerns.

In response to Mayor Trantalis' question, City Clerk Soloman confirmed that the nomination of Lisa Crawford for the Northwest-Progresso-Flagler Heights Redevelopment Board would be removed for further consideration.

Vice Mayor Herbst introduced this Resolution as amended which was read by title only.

He noted the need for a clear consensus from the Commission.

Commissioner Beasley-Pittman remarked on concerns, cited examples and inquired about consensus appointments and individual Commission Member appointments. Interim City Attorney Spence explained related information and said those appointments vary depending upon the Board or Committee. Further comment and discussion ensued.

Commissioner Beasley-Pittman reiterated her concerns about objections to other Commission Member's appointments, noted the personal nature of those objections, and expounded on her viewpoint and the need for Commission Members to work together. Further comment and discussion ensued.

Vice Mayor Herbst concurred with Commissioner Beasley-Pittman's remarks and expounded on his viewpoint that the Commission should adhere to previous Commission practices.
