TITLE: Motion Approving an Agreement for Security Guard Services - Regions
Security Services, Inc. - \$419,760 - (**Commission Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve an Agreement, in substantially the form attached, for Security Guard Services with Regions Security Services Inc, in the initial one (1) year contract term amount of \$419,760; and authorize the City Manager to approve three (3) additional one-year renewal options in the estimated annual renewal amount of \$419,760, for a potential total contract amount of \$1,679,040.

Background

This contract is to provide various levels of security services to the Fiveash Water Treatment Facility, Public Works Utilities Compound, the Development Services Department and at One East Broward (Temporary City Hall Facility), and additional facilities/locations as may be required by other City departments as needed.

On September 22, 2023, the Procurement Services Division issued Invitation to Bid (ITB) Event No. 184 for Security Guard Services and received 12 responses.

The two lowest priced vendors were deemed non-responsive as they did not meet the minimum requirements of the bid; either not bidding on all items or not satisfying the locations requirement of the bid.

The bid provided by Regions Security Services Inc, has met the requirements of the bid and is deemed the lowest, responsive, and responsible bidder. Four (4) of the 12 vendors indicated their status as a Disadvantaged Business Enterprise.

Resource Impact

There will be a current year fiscal impact to the City in the amount of \$313,493. The cost allocation will be \$188,826 for the Public Works Department, \$80,925 for the Development Services Department, and \$43,742 for Human Resources (Temporary City Hall Facility). Future expenditures are contingent upon approval and appropriation of the annual budget.
