TITLE: Quasi-Judicial Resolution Vacating a 16-Foot Utility Easement Located at
3020 S Federal Highway – Airpark Executive, LLC. – Case No. UDP-
EV22009 - (**Commission District 4**)

Recommendation

Staff recommends the City Commission consider a resolution vacating a 16-foot utility easement located at 3020 South Federal Highway.

Background

The applicant, Airpark Executive, LLC, requests to vacate a 16-foot-wide utility easement bisecting the property located at 3020 South Federal Highway. The easement was previously located within an alley which was vacated by Ordinance No. C-86-29. It was retained as a storm drain and utility easement in Official Records Book 13390, Page 438 of the Public Records of Broward County. The easement currently contains Florida Power and Light (FPL) utilities and will be relocated at the applicant's expense as part of the construction of the associated 130,709 square foot 980-unit self-storage facility (Case Number UDP-S22064). The property is in the Heavy Commercial/Light Industrial (B-3) zoning district with the underlying land use of Commercial. A location map is attached as Exhibit 1.

The City's Development Review Committee (DRC) reviewed the easement vacation application on December 13, 2022. All comments have been addressed. The application, applicant's narratives, plans, and utility provider letters stating no objection to the vacation are attached as Exhibit 2. The DRC Comment Report with applicant's responses is attached as Exhibit 3. The sketch and legal description of the proposed vacation is attached as Exhibit 4.

The City Commission shall consider the application, the record, and public comment on the application when determining whether the application meets the criteria for vacation. Pursuant to the City's Unified Land Development Regulations (ULDR) Section 47-24.7, Vacation of Easement, the City Commission is to consider the application and the record and recommendations forwarded by the DRC and shall hear public comment on the

application to determine whether the application meets the following criteria for vacation of an easement:

- a. *The easement is no longer needed for public purposes.*

The easement was previously located within an alley which was vacated and was retained as a storm drain and utility easement. FPL facilities currently located within the proposed vacation of easement area will be relocated as part of the construction of the associated new development of a self-storage facility that will cover the existing easement area. If any additional utility infrastructure is found during the construction of the associated development, the relocation shall be at the expense of the applicant.

- b. *All utilities located within the easement have been or will be relocated pursuant to a relocation plan; and the owner of the utility facilities has consented to the vacation; or a portion of the easement area is maintained; or an easement in a different location has been provided by the utility facilities by the owner to the satisfaction of the city; or any combination of same.*

There is FPL infrastructure currently located within the easement area. The applicant has coordinated with franchise utility providers and shall relocate those utilities as part of the development of the associated self-storage facility. If any additional utility infrastructure is found, the applicant shall coordinate with the franchise utility providers to relocate the found utility at the expense of the applicant. The applicant has obtained letters of no objection from the following providers who have rights to place utilities in the easement: City of Fort Lauderdale Public Works Department, AT&T, Florida Power and Light, TECO Peoples Gas, and Comcast Cable.

Should the City Commission determine that the proposed application meets the criteria for vacation of easement, the following conditions apply:

1. Florida Power and Light (FPL) facilities shall be relocated from the vacated area at the expense of the applicant, and easements shall be dedicated at the new location. Relocated facilities shall be inspected and accepted by FPL.
2. Any City infrastructure known or unknown and found to be within the vacated area shall be relocated at the expense of the applicant, and easements will be dedicated at the new location, and the relocated facilities shall be required to be inspected and accepted by the City's Public Works Department.
3. Any other utility infrastructure known or unknown and found to be within the vacated area shall be relocated at the expense of the applicant, and easements will be dedicated at the new location, and the relocated facilities shall be required to be inspected and accepted by the applicable utility agency or service provider.
4. The applicant shall record a copy of the Easement Vacation Resolution in the Public

Records of Broward County at the applicant's expense, within 30 days from the date of final passage, and the applicant shall provide the City Clerk with a copy of the recorded Resolution.

Resource Impact

There is no fiscal impact associated with this action.
