

RESOLUTION NO. 23-149

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING THE ACCEPTANCE OF GRANT FUNDS FROM THE FLORIDA DEPARTMENT OF HEALTH, DIVISION OF EMERGENCY PREPAREDNESS AND COMMUNITY SUPPORT TO PROVIDE FUNDS FOR THE EXPANSION AND/OR IMPROVEMENTS OF PRE-HOSPITAL EMERGENCY MEDICAL SERVICES ("EMS") IN THE AMOUNT OF \$36,746.25 WITH A LOCAL CASH MATCH OF \$12,248.75; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Health, Division of Emergency Preparedness and Community Support ("FDOH") offers a grant that will require a local match of \$12,248.75; and

WHEREAS, FDOH provides funds for the expansion and/or improvements of pre-hospital Emergency Medical Services ("EMS") by assisting the City of Fort Lauderdale ("City") with the purchase of patient simulators for EMS education; and

WHEREAS, in February 2023, the Fire Rescue Department applied for grant funds through the State of Florida Department of Health – Emergency Medical Services Program; and

WHEREAS, the funds will be used to purchase three (3) advanced multipurpose manikins (adult, pediatric and trauma); and


WHEREAS, the training manikins will allow Fire Rescue's training bureau to provide realistic, relevant, and effective training to personnel;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission of the City of Fort Lauderdale, Florida, accepts grant funds in the amount of \$36,746.25 from the Florida Department of Health, Division of Emergency Preparedness and Community Support with a local cash match in the amount of \$12,248.75.


SECTION 2. That this Resolution shall be in full force and effect upon final passage and adoption.
