**TITLE:** Motion to approve a contract for George T. Lohmeyer (GTL) dewatering building, electrical and conduit replacement re-bid project 11689 – Invitation to Bid (ITB) 443-11294 - \$170,776

---

**Recommendation**

It is recommended that the City Commission award a contract for the George T. Lohmeyer (GTL) dewatering building, electrical and conduit replacement rebid project to the lowest cost, responsive and responsible bidder, Florida Bridge Builders, Inc., in the amount of \$170,776.

**Background**

This construction project number 11689 is part of the annual renewal and replacement scope of work at GTL. The work includes furnishing and installing new surface mounted conduits, supports, wires, and field connections for three existing motors, three new motor controllers, several existing field control devices, and eight electrical power outlets on the third floor of the dewatering building. The work also includes replacing three buckets in the existing Motor Control Centers (MCC-7C and MCC-8C) located in the electrical room at the GTL's dewatering building.

The Procurement Services Division issued an ITB for this re-bid to 2,661 vendors and received four responses. Florida Bridge Builders, Inc. is the lowest cost, responsive and responsible bidder in the amount of \$170,776.

**Resource Impact**

There will be a fiscal impact to the City in the amount of \$170,776 for contract award and \$34,155 for engineering fees, totaling \$204,931.
