Proposed Locations 25 (northbound north A-1-A and NE 23 Street), 26 (northbound north A-1-A and NE 30 Street) and 27 (southbound north A-1-A and NE 30 Street) were removed.

The City Manager advised that as a result of the City Auditor's assistance, a revised pricing mechanism to the one in Commission Agenda Memorandum 13-0220 is proposed. For months that a camera begins operating, the City would pay on a pro rata basis. ATS has agreed to this. The City Auditor explained that staff was concerned that the per violation processing fee could subject the City to legal challenges. As opposed to escrowing funds until all appeals are resolved, staff decided on this alternative. In any event, staff believes there would have been a sufficient number of citations processed to have gotten the City to the maximum fee anyway. The City Manager clarified that staff was looking at developing a pricing mechanism based upon low and high traffic roads. Being that there is a provision in State law that prevents a contingency fee, there was concern that the processing fee could be considered a contingency fee. This is a more conservative approach of \$4,250 maximum on a pro-rated basis.

In response to Commissioner DuBose, the City Manager indicated that a bill to repeal red light cameras entirely has been filed by a legislator in Miami-Dade County.

Alain Jean, representing American Traffic Solutions, Inc., confirmed that Senator Garcia has filed a bill on this topic this this session and did so last year as well. He did not believe it would succeed because the leadership supports this concept. In further response to Commissioner DuBose, he indicated that he does not have life safety data at this time, but offered to provide it to him. The level of motorists running red lights has substantially decreased. Vice Mayor Roberts clarified that this is a matter of life safety and serious injury protection, and not revenue. Although the City currently derives revenue from this program, revenue will decrease when behaviors change over time. He thought the cameras make a difference, but they have not been in place long enough for a true analysis. He was pleased that some partially equipped intersections are being completed. The program's outcomes will become more evident in the next year. He noted that the City is avoiding a controversial issue by no longer issuing citations for right turn violations. Commissioner DuBose requested the life safety data be furnished to show what the program is achieving.

In response to Mayor Seiler, the City Manager advised that the Commission decided which intersections to add when this item was presented in April of 2012. Police Chief Frank Adderley confirmed that there have been no changes since the approval in April of 2012. In further response, Vice Mayor Roberts believed camera locations 25, 26, and 27 as shown in Exhibit 2 were originally proposed, but were not deemed a priority. The cameras were reallocated to intersections with higher accident rates and traffic volume. The City Manager thought the Commission had identified additional locations and they were added. Mayor Seiler called into question the logic for proposing those locations as they are not major intersections. Vice Mayor Roberts agreed. Police Chief Adderley advised that those cameras have not been installed yet. The logic for selecting those locations was based on research from ATS indicating a high volume of red light violators. The City Manager indicated these locations could be removed and staff will present justification at a later date.

Motion made by Commissioner DuBose and seconded by Vice Mayor Roberts to approve the item as amended and described above, and subject to 1) provision of data that the program has enhanced safety and 2) removal of locations 25 (N/B N. A-1-A and NE 23 Street), 26 (N/B North A-1-A and NE 30 Street), and 27 (S/B North A-1-A and NE 30 Street).
