Report Update - CDM Smith, Inc. - \$15,220 Task Order

### **Recommendation**

It is recommended that the City Commission approve Task Order No. 35 (Exhibit 1) in the amount of \$15,220 for the GTL 2017 Capacity Analysis Report Update with CDM Smith, Inc.

### **Background**

The capacity analysis report meets the requirements of Rule 62-600.405, Florida Administrative Code, which was created to ensure that permittees conduct the timely planning, design, and construction of wastewater facilities necessary to provide proper treatment and reuse or disposal of domestic wastewater and management of domestic wastewater residuals. Rule 62-600.405(6), Florida Administrative Code, requires permittees to routinely compare flows being treated at their wastewater facilities against the permitted capacities of the associated treatment plant(s). This task order provides for an update of the annual capacity analysis report using the flow data from GTL from 2016 for the benefit of city-wide development planning and capacity assessments for Large Users.

This Task Order is being entered into pursuant to the General Wastewater Consulting Professional Architectural-Engineering Services agreement with CDM Smith, Inc. (Contract #606-10482), formerly known as Camp Dresser & McKee Inc., approved by City Commission on May 3, 2011 and expiring on May 2, 2018.

## **Resource Impact**

There will be a fiscal impact to the City in the amount of \$15,220 for this task order, and \$3,000 for in-house project management fees for a total of \$18,220. Funds for this purchase in the amount of \$18,220 are available in the FY 2017 Budget in the account listed below:
