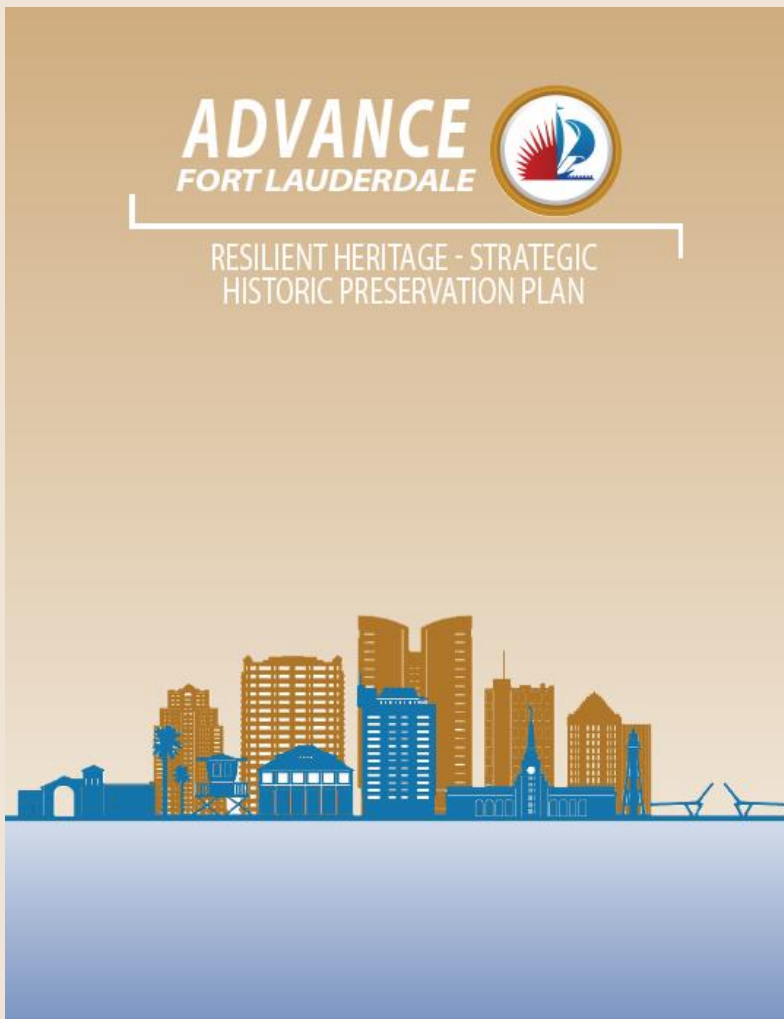

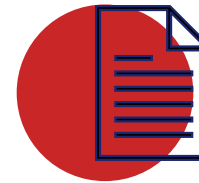


## Goal 2 | Architectural Research Survey

The Strategic Historic Preservation Plan is available on the City's Historic Preservation website and will be shared directly with the following stakeholders:

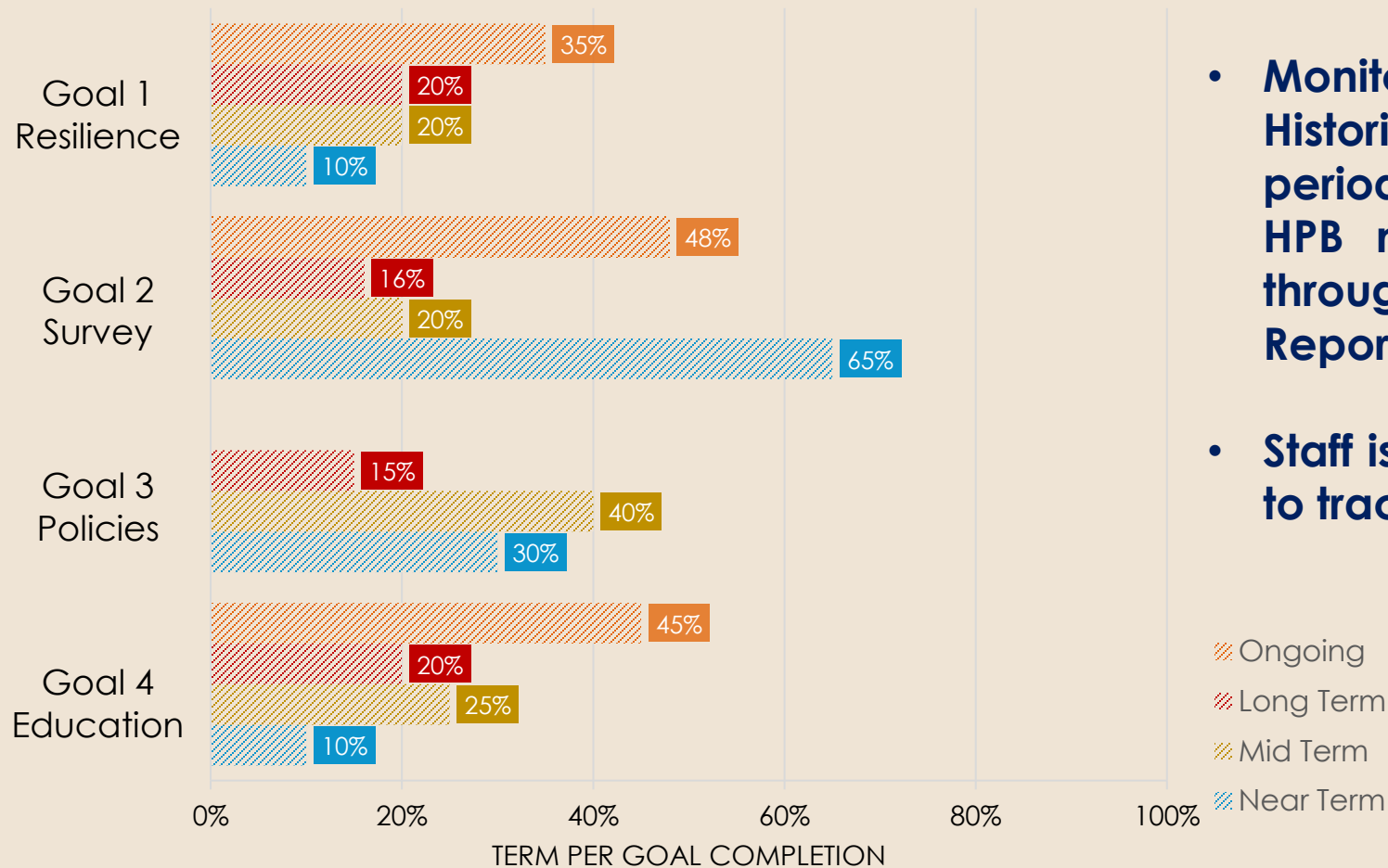
