A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, INCREASING THE BASE SALARY AT A RATE OF 6.13% FOR CERTAIN NON-CLASSIFIED EMPLOYEES PARTICIPATING IN THE CITY'S 401(A) DEFINED CONTRIBUTION MONEY PURCHASE PLAN; INCREASING THE BASE SALARY OF THE CITY MANAGER AT A RATE OF 4.0%; REPEALING ANY AND ALL RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING AN EFFECTIVE DATE.

WHEREAS, by Resolution No. 99-179 the City Commission of the City of Fort Lauderdale authorized establishment of a 401(a) Defined Contribution Money Purchase Plan ("Plan") for non-classified employees; and

WHEREAS, pursuant to Resolution No. 99-179 participation in the Plan was subject to the level and frequency of City contributions to the non-classified employees 401(a) Plan as authorized by the City Commission from time to time; and

WHEREAS, the City currently makes biweekly contributions for the nonclassified employees in the 401(a) Plan based upon a rolling five-year average of the City's required annual contribution to the General Employees Retirement Plan ("GERS"); and

WHEREAS, effective October 1, 2012 the City is revising the contribution rate to the 401(a) Plan for non-classified employees by adopting a contribution rate not to exceed 27.71% of the employee's earnings; and, effective October 1, 2012, revising the contribution rate to the 401(a) Plan for non-classified employees hired on or after October 1, 2012 to establish a fixed contribution rate of 9.0% of the employee's earnings; and by further revising the contribution rate to the 401(a) Plan for non-classified employee's earnings; and by further revising the contribution rate to the 401(a) Plan for non-classified employees hired prior to October 1, 2012 to establish a contribution rate equal to the City's normal cost component of the Annual Required Contribution (ARC) to the City's GERS at a rate not to exceed 19.89% of the employee's earnings with such revision to the contribution rate to take effect simultaneous with the effective date of an ordinance creating a special class over-ride for certain non-classified employees whose salary adjustments resulting from the reduction in the 401(a) contributions would otherwise exceed the maximum salary within the employee's salary range; and

WHEREAS, such adjustments are for a proper municipal purpose and are deemed to be in the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That, with the exception of the City Manager, the base salary of non-classified employees participating in the City's 401(a) Plan be increased by 6.13% to offset the reduction in the City's contribution rate to the non-classified employees 401(a) Plan.

<u>SECTION 2.</u> That the base salary of the City Manager be increased by 4.0% to offset the reduction in the City's contribution rate to the City Manager's 401(a) Plan.

<u>SECTION 3</u>. That any and all Resolutions or parts thereof in conflict herewith are hereby repealed.

<u>SECTION 4.</u> That this Resolution shall take effect simultaneous with the effective date of an ordinance creating a special class over-ride for certain non-classified employees whose salary adjustments resulting from the reduction in the 401(a) contributions would otherwise exceed the maximum salary within the employee's salary range.
