Playmore LLC - \$232,566.72

Recommendation

It is recommended that the City Commission approve the purchase of replacement playground equipment for Charles B. Benneson Park and George English Park from Playmore LLC (Playmore) via the Manatee County School Board Contract 16-0025-MR in the combined amount of \$232,566.72.

Background

The Parks and Recreation Department is requesting approval to replace playground equipment for Charles B. Benneson Park and George English Park in an effort to provide safe and accessible playgrounds for neighbors and visitors. The existing playgrounds have exceeded their life cycle. Each playground will receive new playground equipment with new or restored-to-new surfacing.

Pursuant to Section 2-181(7) of the Code of Ordinances, these purchases will be made in accordance with the Manatee County School Board Contract 16-0025-MR in the total amount of \$232,566.72, whereby such contract or formal bid followed formal bid procedures of sealed written bids, public opening, and legal advertising.

Playmore will provide, deliver and install playground equipment for Benneson Park for a total of \$61,299.63. They will also provide, deliver and install playground equipment for George English Park for a total of \$171,267.09.

Resource Impact

There will be a fiscal impact to the City in the amount of \$232,566.72 contingent upon the approval of the Consolidated Budget Amendment CAM 17-0114.
