Recommendation

Staff recommends the City Commission approve the settlement of the labor relations claim in *Kimberly Maus, Luan Malushi, Richard Fortunato, and Francisco Vetancourt v. City of Fort Lauderdale,* Case No. 22-61889-Civ-Altman, in the aggregate amount of \$130,939 by paying \$19,203.89 to Kimberly Maus, \$15,000 to Laun Malushi, \$15,000 to Richard Fortunato, \$16,734.88 to Francisco Vetancourt, and \$65,000 to Tonja Haddad, P.A., Trust Account.

Background

Kimberly Maus, Luan Malushi, Richard Fortunato, and Francisco Vetancourt are employees who filed a claim for discrimination, and then litigation against the City on September 22, 2022, under § 760.10, Florida Statutes, and Title VII of the Civil Rights Act, seeking claims for emotional distress, compensatory damages, and attorney's fees.

Staff and defense counsel's evaluation of the potential financial exposure to the City determined that a settlement would provide the most cost-effective outcome. Through negotiations, a settlement was reached in the amount of \$130,939, subject to the approval of the City Commission.

The settlement amount of \$130,939 will be distributed in the amounts of \$19,203.89 to Kimberly Maus, \$15,000 to Laun Malushi, \$15,000 to Richard Fortunato, and \$16,734.88 to Francisco Vetancourt for damages, and \$65,000 to Tonja Haddad, P.A., Trust Account for attorney's fees and costs.

Resource Impact

There will be a fiscal impact to the City in the amount of \$130,939.
