TITLE:	Motion Approving Agreement for the Tarpon River Dredging – Arbor Tree and Land, Inc \$620,000 - (Commission District 4)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, with Arbor Tree and Land, Inc. (ATL), for the Tarpon River Dredging Project in the amount of \$620,000.

Background

The proposed project's scope of work includes maintenance dredging of approximately 800 linear feet of the Tarpon River from 100 feet west of the SE 9th Avenue bridge to 700 feet east of the SE 9th Avenue bridge. The estimated quantity of dredge material is 2,000 cubic yards.

On August 25, 2021, the Procurement Services Division issued Invitation to Bid No.12571-613. The City received four bids in response to the solicitation which were opened on September 30, 2021.

The apparent low bidder, Energy Resources, Inc. (Energy), has been deemed nonresponsive, due to the fact, pursuant to Section .08, Specific Experience Required, of the Invitation to Bid, the following must requirements were not submitted:

1) Energy failed to provide three (3) current and verifiable references on self-performed dredging in Florida within the last five (5) years. Energy only listed two projects.

2) Energy failed to provide a resume for the onsite superintendent. The proposed onsite superintendent must have a minimum of seven (7) years' experience in hydraulic or mechanical dredging projects.

3) Energy failed to provide a list of owned/lease equipment, vehicles and all other resources assigned to this project.

Furthermore, Energy also failed to provide a 'Care of Property Plan', which includes a 'Public

Outreach Plan' identifying hazards, hours of operation and spill booms to protect private property, and a 'Spill Response Plan' in case of material release.

The bid submitted by ATL has met all of the requirements of the solicitation and deemed the low responsive and responsible bidder.

None of the bidders indicated their status as a Disadvantaged Business Enterprise.

Resource Impact

There will be a current fiscal year impact to the City in the amount of \$620,000. Funds for this agreement in the amount of \$620,000 are available in the FY 2022 Operating Budget in the account listed below.
