A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A **FEDERALLY FUNDED SUBAWARD** AND **GRANT** AGREEMENT FOR DR - 4709 - SEVERE STORMS. TORNADOES, AND FLOODING (BROWARD), WITH THE DIVISION STATE FLORIDA OF **EMERGENCY** MANAGEMENT, DELEGATING TO THE CITY MANAGER THE AUTHORITY TO EXECUTE THE FEDERALLY FUNDED SUBAWARD AND GRANT **AGREEMENT** AND RELATED DOCUMENTS AND TO APPROVE AND EXECUTE ANY MODIFICATIONS OF THE FEDERALLY FUNDED SUBAWARD AND GRANT AGREEMENT, AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, it is anticipated that the United States Department of Homeland Security ("USDHS") will award the State of Florida funds to reimburse municipalities in Broward County for the April 2023 flood event; and

WHEREAS, City of Fort Lauderdale ("City") staff has been working closely with the Federal Emergency Management Agency ("FEMA") to identify projects for reimbursement that capture damages incurred by the City during the April 2023 flood event; and

WHEREAS, the City intends to submit projects including, but not limited to: debris management, City Hall damages and associated relocation expenses; damages to Parks facilities; emergency pumping activities; stormwater infrastructure desilting; and emergency protective measures for Police and Fire Rescue; and

WHEREAS, it is anticipated that the City will be eligible for reimbursement of allowable expenses through FEMA of 75% and the State of Florida of 12.5%, and the City would be responsible for up to the remaining 12.5% of any costs; and

WHEREAS, the total grant funding and recovery amounts are contingent upon USDHS and State of Florida review and appropriation of each individual project worksheet or obligation;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA THAT:

<u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale, Florida, approves a Federally Funded Subaward and Grant Agreement for DR - 4709 - Severe Storms, Tornadoes, and Flooding (Broward), ("Agreement"), in substantially the form attached to City Commission Agenda Memo #23-0759, and delegates to the City Manager the authority to execute the Agreement and any related documents, and to approve and execute any modifications of the Agreement.

<u>SECTION 2</u>. That if any clause, section, or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

<u>SECTION 3</u>. That this Resolution shall be in full force and effect immediately upon its adoption.
