Section A

1. **Summary of the proposed ordinance, to include the public purpose to be served by the proposed ordinance, such as serving the public health, safety, morals, and welfare of the City.** The proposed amendment to Chapter 17 - Noise Control aims to establish a balanced approach to noise regulation in the City. It seeks to enhance the administration and enforcement of the Noise Control Program, ensuring that businesses can operate effectively while maintaining a reasonable noise comfort level for residents. This initiative serves the public purpose of protecting the health, safety, morals, and welfare of the community by addressing noise concerns and fostering a harmonious environment for both businesses and residents.

2. **Estimate of direct economic impact of the proposed ordinance on private, for-profit businesses in the City.**

The fees related to the enforcement of Chapter 17 - Noise Control are detailed in Chapter 11 - Code Enforcement of the City's Code of Ordinances. These fees are not new.
