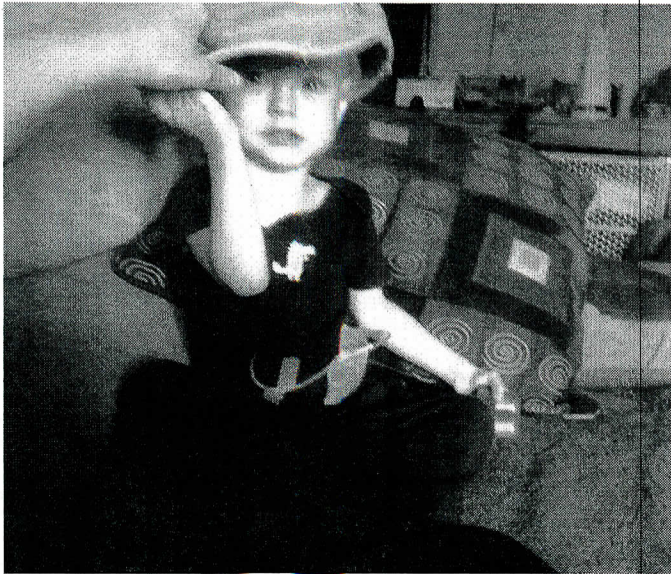
Based on our current balance balance in addition to the invoice totals for April, May, and June our funds have been fully expended.

Testimony from City of Fort Lauderdale Respite Client:

"I would do anything I could to help support the Broward Children's Center Respite Program. All of their staff have been so awesome I can't even begin to explain. This program stepped in when we had no one else to turn to and I can't imagine what we would do without them. You don't know what it's like to not even be able to do basic things like shower or clean your home. They were there for us when we needed it the most."
- Danielle, mother of Tristan, age 2. Tristan and his mother almost died during birth. Tristan suffered from loss of oxygen to the brain, one kidney, a bleeding ulcer, and an unattached esophagus to his stomach. He was diagnosed with VATER syndrome and required a feeding tube, therapies, and venting every 30 minutes. They have no family support in the area, are low income, and Tristan's father is in school and working in order to support their family and Tristan's medical needs.

Impact Story for City of Fort Lauderdale Respite Client:

Reinder is an 8 year old boy living with his father in Fort Lauderdale. Reinder's mother passed away 5 years ago and his father is now alone caring for his young son with autism. Reinder's father lost his job due to a lack of special needs child care for his son after his wife died. Thanks to the City of Fort Lauderdale funding we were able to enroll Reinder 2 weeks ago. Upon going to the home we found they had no furniture, no food, and no electricity. We immediately not only began respite services for the family but also provided special needs case management to help provide the family with food, utility assistance, and a multitude of other programs and resources. As the family has no car we provided free transportation for Reinder to come to our center for full days of air conditioning, games, activities, hot meals, and safety. Reinder has been happy, talkative, and making new friends with other children and our staff. None of this would have been possible without our funding from the City of Fort Lauderdale.
