## **EXTENSION TO AGREEMENT**

THIS IS AN EXTENSION TO THE FACILITY USE AGREEMENT made and entered into this 3rd day of September , 2013, by and between:

CITY OF FORT LAUDERDALE, a municipal corporation of the State of Florida, hereinafter referred to as "City",

and

BROWARD COUNTY R.C. RACE CLUB, INC., a Florida non profit corporation, hereinafter referred to as "USER"

WHEREAS, City and USER entered into a certain Facility Use Agreement to allow USER to operate remote control miniature cars at a portion of Mills Pond Park known as the "Race Track" for an initial term of one (1) year beginning October 1, 2012 and ending on September 30, 2013 ("Agreement"); and

WHEREAS, pursuant to Section 1 of the Agreement, the City and USER have the option to extend the term of the Agreement for two additional one-year terms; and

WHEREAS, the parties now desire to exercise the first option to extend the term of the Agreement for an additional one year term; and

WHEREAS, pursuant to Motion, adopted at its meeting of <u>September 3</u>, 2013, the City Commission authorized the extension of the Agreement for an additional one year term; and

NOW THEREFORE, in consideration of the mutual promises and covenants set forth below, and other good and valuable considerations, the receipt and adequacy of which are hereby acknowledge, the parties agree as follows:

- 1. The foregoing recitals are true and correct and incorporated herein by reference.
- 2. Pursuant to Section 1 of the Agreement, the term of the Agreement is hereby extended for an additional one year term beginning October 1, 2013 and ending September 30, 2014 and USER shall be required to pay City \$800.00 per month plus sales tax as set forth in Section 1 of the Agreement.
- 3. All other terms and provisions of the original Agreement between the parties are hereby ratified, reaffirmed and shall remain in full force and effect.
