TITLE: Motion to approve a proprietary purchase for services and parts to repair four clarifier drive units and one service platform at the George T. Lohmeyer Wastewater Treatment Plant (GTL) - \$397,648

Recommendation

It is recommended that the City Commission approve the proprietary purchase for services and parts for four clarifier drive units and one service platform at GTL from Ovivo USA, LLC., in substantially the form attached, in the amount of \$397,648.

Background

GTL has eleven secondary clarifiers in its treatment process. These clarifiers collect settled solids which are returned to the system for biological treatment of wastes. Four of those clarifiers have rotating drive units which have deteriorated to the point of needing to be replaced or rebuilt (see exhibits 2, 3 and 4). Also, one of the clarifiers has a severely corroded service platform in need of replacement. The scope of this work includes removal, disassembly and inspection, rebuild or replacement, and reinstallation of drive units. Main and worm gear covers will be stainless steel. One center service platform will also be replaced. The City, in conjunction with the wastewater consultant CDM Smith, Inc., annually prepares a renewal and replacement requirement analysis which includes the rehabilitation cost of all facility clarifiers. These clarifiers were manufactured by Eimco (now Ovivo). They are the sole source provider of service and parts for this equipment.

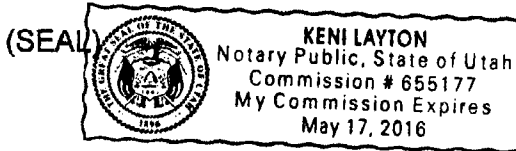
