- b. Earl brought up the method of measuring oversized vessels that are greater than 1/3 the width of the canal. It was suggested that a surveyor would be a better method of measurement. Code currently uses the BCPA website map to measure the width of the boats or uses the manufacturers specifications.

This subject should be brought up at the next meeting to review if surveyors or other methods should be enlisted to evaluate vessel widths in the canals.
