**FIRST RENEWAL OF AGREEMENT
BETWEEN THE CITY OF FORT LAUDERDALE AND ZYSCOVICH, INC.**

THIS IS A FIRST RENEWAL OF AGREEMENT, made and entered into this 18th day of February, 2014 by and between CITY OF FORT LAUDERDALE, a Florida municipality, ("CITY"), and ZYSCOVICH, INC., a Florida corporation ("CONSULTANT").

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida, at its meeting of February 21, 2012, (M-4), approved an Agreement between the City of Fort Lauderdale and Zyscovich, Inc., for Consultant Services for Architectural – Engineering Services Continuing Contract, RFQ #616-10754, ("Agreement"), for an initial two (2) year period; and

WHEREAS, Section 6.1 of the Agreement provides that "[t]he CITY shall have the option to renew this Agreement for three (3) successive one (1) year terms under the same terms, conditions, and compensation as set forth herein"; and

WHEREAS, the CITY and the CONSULTANT wish to renew the Agreement for a one (1) year period until February 20, 2015; and

WHEREAS, at its meeting of February 18, 2014, the City Commission, by motion, authorized the proper City Officials to execute this renewal of the Agreement,

NOW, THEREFORE, the CITY and the CONSULTANT agree as follows:

1. The Agreement between CITY and CONSULTANT dated February 21, 2012, is hereby renewed under the same terms, conditions, and compensation as set forth in the Agreement for a one (1) year term beginning on February 21, 2014, and expiring on February 20, 2015.

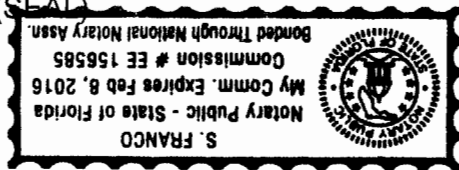
