TITLE: Motion Approving an Agreement for Armored Car Services - IBI

International Logistics Inc. - \$109,703 (estimated two-year total) -

(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve an Agreement, in substantially the form attached, for Armored Car Services with IBI International Logistics Inc., for an initial two (2)-year term in the amount of \$109,703; and authorize the City Manager to approve three (3) additional one (1)-year renewal options, for an estimated annual amount of \$54,852 for a potential total contract amount of \$274,259, contingent upon appropriation of funds.

Background

Armored car services are required to pick up bank deposits from several city locations. All deposits are delivered to the City's designated bank on the next business day. Additional services include the delivery of sealable bank bags and change requests from the bank.

On February 7, 2024, the Procurement Services Division issued Invitation to Bid (ITB) Event No. 213 for Armored Car Services, which opened on March 6, 2024. Two (2) responses were received.

The bid submitted by IBI International Logistics Inc. met the solicitation requirements and is deemed the low responsive, responsible bidder.

No bidders indicated their status as a Disadvantaged Business Enterprise.
