TITLE: Motion Approving Fiscal Year 2026 Beach Business Improvement District
Grant Participation Agreement with Rainbow Sidekick Inc. for the Beach
Party Event Associated with Lauderdale Tropical Bear Week - \$5,000 -
(Commission District 2)

Recommendation

Staff recommends the City Commission approve the Fiscal Year (FY) 2026 Beach Business Improvement District (BBID) Grant Participation Agreement with Rainbow Sidekick Inc., in substantially the form attached, to support the Lauderdale Tropical Bear Week Beach Party on Sunday, April 5, 2026, in the amount of \$5,000.

Background

At its May 12, 2025 meeting, as part of the annual event grant application review, the BBID Advisory Committee considered two (2) requests from Rainbow Sidekick Inc. The first was for \$15,000 in sponsorship funding to support a single-day beach party event in November 2025. While BBID allocated \$5,000 in funding, Rainbow Sidekick Inc. cancelled the November 2025 event.

The second request was for sponsorship of a beach party held at the conclusion of Lauderdale Tropical Bear Week. The beach party has taken place in Fort Lauderdale for the past three (3) years and Lauderdale Tropical Bear Week has taken place for five (5) years. Lauderdale Tropical Bear Week is a six (6)-day festival held at multiple locations throughout Fort Lauderdale and Wilton Manors and attracts thousands of out-of-state and international visitors, generating significant hotel stays and revenue at local businesses.

In 2026, the six (6)-day festival begins Tuesday, March 31, 2026. Approximately eleven (11) events are scheduled. The week concludes with a beach party scheduled for Sunday, April 5, 2026, on Fort Lauderdale Beach, directly across from Hugh Taylor Birch State Park. Additional event and sponsorship details are provided in the application (Exhibit 1).

While \$15,000 in sponsorship funding was requested, the BBID Advisory Committee recommended approval of \$5,000 for this event by a vote of 8 - 0 (Exhibit 2).

The sponsorship provides the BBID with high-visibility marketing exposure through digital media and promotions. The other deliverables associated with this Grant Participation Agreement include:

- Sponsor Recognition - Recognition of BBID in promotions and marketing specific to the Event on April 5, 2026, featuring the BBID’s consumer-facing brand and logo, DiscoverFTLBeach.com;
- Website Visibility - Sponsor recognition on the event website including display of the DiscoverFTLBeach.com brand and a link directing visitors to the site as a primary resource for BBID hotels, dining, and attractions;
- Digital & Email Promotion - Inclusion of the DiscoverFTLBeach.com brand in digital marketing and targeted email campaigns promoting the Event and BBID businesses;
- Social Media Promotion - Sponsor recognition and promotional mentions across official event social media channels highlighting the DiscoverFTLBeach.com brand; and
- Visitor Promotion - Messaging encouraging Beach Party attendees to stay, dine, shop, and explore within the BBID district and visit DiscoverFTLBeach.com for visitor information.

Funding History

The applicant has not previously received funding from the BBID.
