TITLE: Motion to approve contract for electrical improvements to Smoker Park, North Riverwalk and Esplanade Park – ITB 223-11029 - \$96,932.22

Recommendation

It is recommended that the City Commission approve a contract with Sunshine State Electric of Florida, Inc. in the total amount of \$96,932.22 for electrical improvements to Smoker Park, North Riverwalk and Esplanade Park.

Background

The work includes electrical improvements and light pole installation in the three (3) areas as follows:

<u>Smoker Park</u>: Installation of three (3) Riverwalk light pole assemblies with all associated conduits and wiring, energizing the two existing power distribution panels.

<u>North Riverwalk Lighting</u>: Installation of eight (8) Riverwalk light pole assemblies with all associated conduits and wiring.

<u>Esplanade Park</u>: Installation of power distribution, fed by existing FPL transformers; installation of light pole for events; and more enhanced lighting of Riverwalk.

Two bids were received with Sunshine State Electric of Florida, Inc. submitting the lowest cost, responsive and responsible bid. The bid, however, included minor irregularities: they originally included more than the five percent for mobilization cost as specified in the bid, and they also had a minor mathematical error. Regarding the math error, a correction was made to change a line item from a unit of one to a unit of three, per bid specifications. Both irregularities were corrected to adhere to the bid requirements and corrections were agreed upon by the contractor. The corrections resulted in the bid being further reduced.

Resource Impact

There is a fiscal impact to the City in the amount of \$124,751.77; \$96,932.22 for the construction contract and \$27,819.55 for engineering fees. Funding is contingent upon approval of agenda item #12-2644, the consolidated budget amendment
