SECOND EXTENSION TO AGREEMENT

THIS IS A SECOND EXTENSION TO AGREEMENT, made and entered into this 19th day of February 2013 by and between:

CITY OF FORT LAUDERDALE, a municipal
Corporation of the State of Florida,
(hereinafter referred to as "CITY")

and

EE&G Environmental Services, LLC, a Florida
Corporation (hereinafter referred to as
"CONSULTANT").

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of June 21, 2011, authorized the proper officials by motion to execute an Agreement between CONSULTANT and CITY authorizing the performance of services in connection with Agreement, 616-10632 General Environmental Engineering Consultant Services (the "Agreement"); and

WHEREAS, Section 6.1 of the Agreement authorizes renewal for three (3) successive one (1) year terms upon mutual consent of the parties; and

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of June 5, 2012, authorized the proper officials by motion to execute a First Extension and Amendment to Agreement between CONSULTANT and CITY authorizing the performance of services until June 20, 2013; and

WHEREAS, CITY wishes to retain CONSULTANT to provide, and CONSULTANT desires to provide, contracted professional consultant services to CITY for an additional one year (1) period until June 20, 2014, utilizing the contract prices of the original Agreement; and

WHEREAS, at its meeting of February 19, 2013, the City Commission, by motion, authorized the proper City Officials to execute this Second Extension to Agreement;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:

Section 1. The foregoing recitals are true and correct and are made a part of this Second Extension to Agreement.

Section 2. That the Agreement between CITY and CONSULTANT dated June 21, 2011 is hereby extended for an additional one year (1) period, said term expiring on June 20, 2014.
