**P**LEASE TAKE NOTICE. The City is amending the 2024–2025 Annual Action Plan in accordance with the Substantial Change Policy outlined in the HUD-approved 2020–2024 Consolidated Plan. This amendment addresses any modifications to assisted activities that result from the introduction or cancellation of a program, or changes to the purpose, scope, location, beneficiary, or funding allocation of which necessitate a formal update to the Annual Action Plan.

**T**he amendment to the 2024-2025 Annual Action Plan will fund an additional \$331,000.00 of unused Housing Opportunities for Persons with Aids (HOPWA) program funds to Broward Regional Health Planning Council Inc., to provide additional Tenant Based Rental Assistance for people living with HIV/AIDS.
