TITLE: Motion Approving a First Amendment to Temporary Beach License and Outdoor Event Agreement with Royal Recordings, LLC for the 2025 Oceans of Soul Jazz Festival on Fort Lauderdale Beach - (Commission Districts 2 and 4)

Recommendation

Staff recommend that the City Commission approve a first amendment to a temporary beach license and outdoor event agreement with a request for extended hours for music with Royal Recordings, LLC, in substantially the form attached, for a music event on Fort Lauderdale Beach known as the 2025 Oceans of Soul Jazz Festival.

Background

On January 7, 2025, the City Commission approved a temporary beach license and outdoor event agreement with Royal Recordings, LLC to host the 2025 Oceans of Soul Jazz Festival on the Fort Lauderdale Beach from September 2, 2025, through September 10, 2025, which includes the setup period, event period, and breakdown period ("Event").

During the January 7, 2025 City Commission meeting, the event dates were discussed, and it was determined that dates in December 2025 could be an option for the event dates. The Event organizer notified City staff that they wish to reschedule the 2025 Oceans of Soul Jazz Festival as follows:

- Set-up Dates: December 2, 2025, through December 5, 2025 (8:00am – 7:00pm)
- Event Dates: December 6, 2025, through December 7, 2025 (1:00pm – 10:00pm)
- Breakdown Date: December 8, 2025, through December 10, 2025 (8:00am – 7:00pm)

The event impacts are from December 2, 2025, through December 10, 2025, inclusive of any setup period, event period, and breakdown period, as well as all previously approved special exceptions or music exemptions, or both. There is no application fee collected for this agreement as it is being rescheduled from a prior approval.

This event organizer is requesting the following special permissions that require City Commission approval:

Amplified music:

• The applicant is requesting permission for one additional hour of amplified music, until 10:00pm, on Sunday, December 7, 2025

The event organizer will pay all event costs and submit the required certificates of insurance. The City is requiring the organizer to post an amount in escrow, equal to 110% of the City's estimated service costs. The organizer will also secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been notified as appropriate regarding events in their areas. The organizer will be charged a temporary beach user fee of \$500 per day, including event set-up and breakdown days.
