A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, RESCHEDULING THE JUNE 16, 2026, CONFERENCE MEETING OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, FROM JUNE 16, 2026, AT 1:30 P.M., TO JUNE 16, 2026, AT 1:00 P.M., AND PROVIDING FOR PUBLICATION, RESCISSION OF CONFLICTING RESOLUTION PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, the business of the City Commission is such that it would be advantageous to reschedule the City Commission's Conference Meeting of June 16, 2026, at 1:30 p.m., to June 16, 2026, at 1:00 p.m.;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Conference Meeting of the City Commission of the City of Fort Lauderdale, Florida, scheduled for June 16, 2026, at 1:30 p.m., is hereby rescheduled to June 16, 2026, at 1:00 p.m.

SECTION 2. That the City Clerk shall publish this Resolution in the official newspaper of the City once at least three (3) days before June 16, 2026.

SECTION 3. That any resolution or part of a resolution in conflict herewith be, and is hereby rescinded to the extent of such conflict.

SECTION 4. That this Resolution shall be in full force and effect upon its adoption.
