Hello Everyone -

Yes, this is an eligible HOPWA activity; there are other legal service entities funded across the country for this activity – of course HOPWA will pay for services only serving persons living with HIV/AIDS who are at or below 80% AMI. I have listed 3 project sponsors below if you wish to discuss their services in more depth.

Generally, the HOPWA category they are funded under is Housing Information Services - 24CFR 574.300(b)(1):Housing information services including, but not limited to, counseling, information, and referral services to assist an eligible person to locate, acquire, finance and maintain housing. This may also include fair housing counseling for eligible persons who may encounter discrimination on the basis of race, color, religion, sex, age, national origin, familial status, or handicap; but could also be considered a support service.

I will have a look at your letter now and get back to you with any further comments – ultimately approval of this activity would come through Maria and John at the Miami Field Office as your regional jurisdiction – and be included in your Con Plan/Annual Action Plan. Take care......M.

Basically, the City conducted a competitive process to procure HOPWA agencies that will provide **housing services** and/or **non-housing supportive services**. One of the successful respondents was Legal Aid of Broward County. Legal Aid proposes to provide non-housing supportive services (legal services) to our HOPWA clients.
