TITLE: Motion Approving Consent to Assignment and Assumption of Agreement
from Electric Supply of Tampa, LLC to World Electric Supply, LLC -
(**Commission Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve a Consent to Assignment and Assumption of Agreement, in substantially the form attached, for streetlight fixtures from Electric Supply of Tampa, LLC to World Electric Supply, LLC.

Background

On December 19, 2023, the City awarded Invitation to Bid (Event) No. 111-4, for an initial one-year term with three one-year renewals to Electric Supply of Tampa, LLC for streetlight fixtures (CAM #23-1135). The agreement is in the first renewal period until December 18, 2025.

On June 24, 2024, Electric Supply of Tampa, LLC (Assignor) was acquired by World Electric Supply, LLC (Assignee). As part of the transaction, the assignor assigned its contracts to the assignee and assignee assumed certain liabilities as outlined in the Assignment of Assets (Exhibit 3).

The Agreement between the City and Electric Supply of Tampa, LLC, Section N., Assignment and Performance, states in part: "Neither this Agreement nor any right or interest herein shall be assigned, transferred, or encumbered without the prior written consent of the other Party" (Exhibit 2).

Staff is hereby requesting approval by the City Commission to approve the assignment and assumption from Electric Supply of Tampa, LLC to World Electric Supply, LLC.
