ORDINANCE NO. C-14-15

AN ORDINANCE AMENDING ORDINANCE NO. C-14-09 RECORDED IN OFFICIAL RECORDS BOOK 50569, PAGES 354-358 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, TO REPLACE EXHIBIT "A" ATTACHED AND INCORPORATED THERETO AND LEGALLY DESCRIBING PORTIONS OF THE RIGHT-OF-WAY VACATED, ABANDONED AND CLOSED BY SAID ORDINANCE.

WHEREAS, pursuant to Ordinance No. C-14-09 adopted on February 18, 2014, ("Ordinance"), the City Commission vacated all that portion of the right-of-way dedicated as Southwest Second Court located east of Southwest 27th Avenue and west of Southwest 26th Avenue; and

WHEREAS, Exhibit "A" contained a legal description and sketch that did not correspond with the right-of-way vacated; and

WHEREAS, the record of the public hearing held on February 4 and February 18, 2014 clearly supports the intent to vacate Southwest Second Court; and

WHEREAS, the City Clerk notified the public of a public meeting to be held on Tuesday, March 4, 2014, and Tuesday, March 18, 2014, at 6:00 o'clock P.M. in the City Commission Room, City Hall, Fort Lauderdale, Florida for the purpose of hearing any public comment to the amendment of Ordinance No. C-14-09; and

WHEREAS, such public meeting was duly held at the time and place designated and due notice of same was given by publication as is required by law, and the City Commission has determined that the attachment of the incorrect exhibit constitutes a scrivener's error to be corrected by the amendment of Ordinance No. C-14-09 to replace Exhibit "A";

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That Ordinance No. C-14-09 vacating that portion of the right-of-way dedicated as Southwest Second Court adopted on February 18, 2014 is hereby amended to replace Exhibit "A" attached thereto with Exhibit "A" attached hereto ("Replacement Exhibit 'A'").

SECTION 2. That except as amended, the provisions of Ordinance No. C-14-09 adopted on February 18, 2014 are hereby ratified and reaffirmed.

SECTION 3. That Ordinance No. C-14-08 vacating all that portion of the right-of-way dedicated as Southwest Second Street also adopted on February 18, 2014 is expressly unaffected by this Ordinance.

SECTION 4. That a copy of Ordinance No. C-14-09 with the Replacement Exhibit "A" attached as Exhibit "A" shall be recorded in the Public Records of Broward County by the City Clerk within 30 days from the date of final passage.


SECTION 5. That if any clause, section or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

SECTION 6. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed.

SECTION 7. That this Ordinance shall be in full force and effect upon adoption.



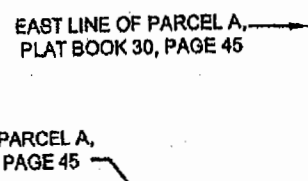

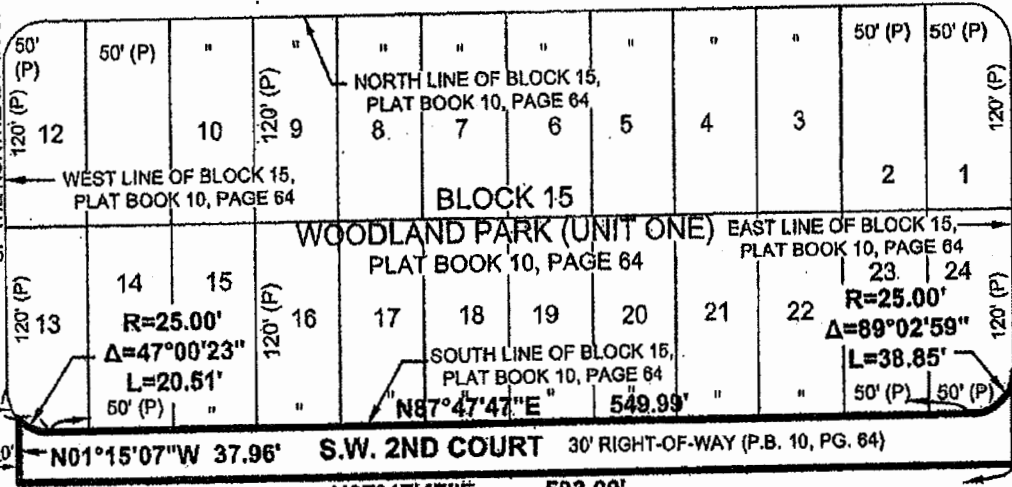
