TITLE: Revised Pur-13 - Motion to award a one-year contract for Annual Utilities

Restoration – Invitation to Bid (ITB) 343-11405 - \$699,745.50

Recommendation

It is recommended that the City Commission make a dual award of a one-year contract for the purchase of Annual Utilities Restoration to Molloy Bros. Inc. and Wrangler Construction Inc., utilizing the City's construction contract, in the estimated annual amount of \$699,745.50 and authorize the City Manager to approve three, one-year renewal options, contingent upon appropriation of funds.

Background

The scope of work includes the repair of gravity sewer mains, sanitary sewer components and construction, limited storm sewer repair, water and sewer pressure pipe repairs as well as related work. The agreement encompasses the City's utility service area. The scope of work includes associated roadway and right-of-way restoration. The contract provides the ability to complete repairs beyond the capacity of City crews and equipment; work will be assigned on an as-needed basis. The contract sum is an estimate and not a guarantee of the amount of work that will be assigned.

ITB 343-11405 was issued on May 20, 2014. The bid opening was held on June 26, 2014 and two bids were received. A 5% local business preference was applied to the bid submitted by Molloy Bros. Inc. Both firms have met the requirements of the bid specifications and a dual award is being recommended to Molloy Bros Inc. as the primary contractor and Wrangler Construction Inc. as the secondary contractor. Staff recommends that the primary contractor be assigned all work that can be performed adequately and satisfactorily. In the event that the primary contractor does not have the capacity for additional assignments, then the work shall be assigned to the secondary contractor. Staff anticipates assigning approximately 60%–80%–90% of the work to the primary contractor.

Resource Impact

There will be a fiscal impact in the estimated amount of \$699,745.50 for the contract and \$90,678 for engineering fees, or a total amount of \$790,423.50. Purchases are made on an as-needed basis and charged to individual budgets per available funds and in accordance with unit pricing. Future expenditures are contingent upon approval and appropriation of the annual budget.
