

RESOLUTION NO. 24-185

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF A LOCALLY FUNDED AGREEMENT AND THREE-PARTY ESCROW AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION, FOR ADDITIONAL IMPROVEMENTS WITHIN THE RIGHT-OF-WAY OF STATE ROAD A1A SOUTH OF NORTHEAST 14TH COURT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Transportation ("FDOT") performed an analysis of the area on SR-A1A/N. Fort Lauderdale Beach Boulevard south of Northeast 14th Court, in Broward County, Florida and determined that a signalized crosswalk is warranted and has programmed the project for construction as part of their work program; and

WHEREAS, FDOT engaged in construction work related to the installation of the new pedestrian crosswalk on SR-A1A/N. Fort Lauderdale Beach Boulevard south of Northeast 14th Court; and

WHEREAS, as part of FDOT's continued construction work, the City has requested that FDOT perform additional work by installing decorative elements to match the existing streetscape on SR-A1A/N. Fort Lauderdale Beach Boulevard; and

WHEREAS, the City and FDOT wish to execute a Locally Funded Agreement to provide funding for the decorative elements of the mid-block pedestrian crossing including construction (installation) of a stamped asphalt crosswalk, pavers in the bulb-outs, and the construction of a pedestrian light fixture; and

WHEREAS, the total cost of FDOT's construction work and the project is estimated to be Six Hundred Seventy-Two Thousand Five Hundred Forty-Two Dollars and Zero Cents (\$672,542.00) and the City's funding share for the project is an estimated amount of Eighty-Two Thousand Nine Hundred Seventeen Dollars and Zero Cents (\$82,917.00);


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. The Locally Funded Agreement in the amount of Eighty-Two Thousand Nine Hundred Seventeen Dollars and Zero Cents (\$82,917.00) and the Three-Party Escrow Agreement between the City of Fort Lauderdale, Florida, and the Florida Department of Transportation for the construction (installation) of a stamped asphalt crosswalk, pavers in the new bulb-outs, and the construction of a pedestrian light fixture within the right-of-way of State Road A1A South of NE 14th Court, are hereby approved.

SECTION 2. The office of the City Attorney shall review and approve as to form all documents prior to their execution.

SECTION 3. That this Resolution shall be in full force and effect upon final passage and adoption.
