## **RESOLUTION NO. 13-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION NO. 03-17 WHICH ESTABLISHED THE UTILITY ADVISORY COMMITTEE BY EXTENDING ITS TERM THROUGH DECEMBER 31. 2013 AND **FURTHER** AUTHORIZING OF THE EXISTENCE Α TREE SUBCOMMITTEE UNDER THE UTILITY **ADVISORY** COMMITTEE THROUGH DECEMBER 31, 2013; PROVIDING FOR SEVERABILITY; FURTHER, PROVIDING FOR REPEAL OF CLAUSES IN CONFLICT HEREWITH; AND PROVIDING FOR EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 03-17 adopted on February 4, 2003, the City Commission established the Utility Advisory Committee of the City of Fort Lauderdale, Florida for a period terminating on December 31, 2003; and

WHEREAS, pursuant to Resolution No. 04-12 adopted on January 6, 2004, the City Commission extended the term of the Utility Advisory Committee for a period of one year to terminate on December 31, 2004; and

WHEREAS, pursuant to Resolution No. 05-18 adopted on January 18, 2005, the City Commission extended the term for the Utility Advisory Committee an additional one year period to terminate on December 31, 2005; and

WHEREAS, pursuant to Resolution No. 05-222 adopted on December 20, 2005, the City Commission extended the term for the Utility Advisory Committee an additional one year period to terminate on December 31, 2006; and

WHEREAS, pursuant to Resolution No. 06-201 adopted on December 12, 2006, the City Commission extended the term for the Utility Advisory Committee an additional one year period to terminate on December 31, 2007; and

WHEREAS, pursuant to Resolution No. 07-259 adopted on December 18, 2007, the City Commission extended the term for the Utility Advisory Committee for an additional one year period to terminate on December 31, 2008; and

WHEREAS, pursuant to Resolution No. 09-07, adopted January 6, 2009, the City Commission extended the term for the Utility Advisory Committee for an additional one year period to terminate on December 31, 2009; and

WHEREAS, pursuant to Resolution No. 10-13, adopted January 6, 2010, the City Commission extended the term for the Utility Advisory Committee for an additional one year period to terminate on December 31, 2010; and

WHEREAS, pursuant to Resolution No. 10-354, adopted December 21, 2010, the City Commission extended the term of the Utility Advisory Committee for an additional one year period to terminate on December 31, 2011 and further authorized the existence of a Tree Subcommittee under the Utility Advisory Committee through December 31, 2011; and

WHEREAS, pursuant to Resolution No. 12-37, adopted February 21, 2012, the City Commission extended the term for the Utility Advisory Committee for an additional one year period to terminate on December 31, 2012; and

WHEREAS, it is recommended that the term of the Utility Advisory Committee be extended until December 31, 2013; and

WHEREAS, the Utility Advisory Committee has referred specialized matters to a Tree Subcommittee comprised of three (3) members of the Utility Advisory Committee;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the term of existence of the Utility Advisory Committee is extended through December 31, 2013.

<u>SECTION 2</u>. That the City Commission hereby authorizes the existence of a Tree Subcommittee under the Utility Advisory Committee, said Subcommittee to consist of three (3) members of the Utility Advisory Committee, to be appointed by the Utility Advisory Committee.

The Tree Subcommittee is hereby authorized to exist for a period terminating December 31, 2013.

<u>SECTION 3.</u> That if any clause, section or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

<u>SECTION 4.</u> That all Resolutions or parts of Resolutions in conflict herewith, be and the same are hereby repealed.

<u>SECTION 5.</u> This Resolution shall take effect immediately upon passage.
