TITLE: Motion Approving Agreements for Stormwater Infrastructure Cleaning and

Maintenance - EnviroWaste Services Group, Inc. and Drainage Partners

LLC -\$500,000 - (Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve two (2) separate, two-year agreements, in substantially the forms attached, for the purchase of stormwater infrastructure cleaning and maintenance services, from EnviroWaste Services Group, Inc. (ESG) and Drainage Partners LLC (DP) in the estimated contract amount of \$500,000, collectively, during the initial term (\$250,000 estimated in Fiscal Year 2022 and \$250,000 estimated in Fiscal Year 2023); and authorize the City Manager to approve two (2), two-year renewal options, contingent upon appropriation of funds.

Background

The purpose of this Agreement is to provide stormwater infrastructure cleaning and maintenance services for stormwater systems within City facilities and rights-of-way of the City. The scope of work for proposed agreements includes CCTV inspection, cleaning of stormwater pipelines, structures, manholes, outfalls, tidal valves, exfiltration trenches, drainage ditches, drainage wells, junction boxes, other drainage components and appurtenances.

The Procurement Services Division issued Invitation to Bid No. 12520-813 on June 30, 2021 for stormwater infrastructure cleaning and maintenance services. On August 12, 2021, the City received a total of five (5) bids. No bidder indicated its status as a Disadvantaged Business Enterprise. The apparent low bidder, A & A Drainage & VAC Services Inc., failed to bid on all items, as required by the solicitation, and was determined to be non-responsive. The bids submitted by ESG and DP met all of the specifications and requirements of the solicitation and both have been deemed the lowest cost, responsive and responsible bidders.

Resource Impact

Funds for this agreement in the amount of \$250,000 are available in the FY 2022 Operating Budget in the accounts listed below. Future years' expenditures are contingent upon the approval and appropriation of the annual budgets.
