

RESOLUTION NO. 23-62

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH THE FLORIDA DEPARTMENT OF HIGHWAY SAFETY AND MOTOR VEHICLES, FOR GOVERNMENTAL ENTITY ACCESS TO THE DRIVER AND VEHICLE INFORMATION DATABASE SYSTEM; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY OR INCIDENTAL TO THE MEMORANDUM OF UNDERSTANDING AND AUTHORIZING THE CITY MANAGER AND THE CITY MANAGER'S QUALIFIED DESIGNEE TO EXECUTE THE ATTESTATION STATEMENTS AND QUARTERLY QUALITY CONTROL REVIEW REPORTS INCIDENTAL TO THE MEMORANDUM OF UNDERSTANDING; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Fort Lauderdale's Transportation and Mobility Department's Parking Services Division requires electronic access to the Florida Department of Highway Safety and Motor Vehicles' Driver and Vehicle Information Database System ("DAVID"), to obtain information related to the issuance of parking citations; and

WHEREAS, the Florida Department of Highway Safety and Motor Vehicles ("FLHSMV") requires the City of Fort Lauderdale to execute a Memorandum of Understanding as a prerequisite to receiving electronic access to the DAVID system; and

WHEREAS, the City entered into a Memorandum of Understanding ("MOU") with the FLHSMV for access to the DAVID system on June 27, 2017, for a term of six (6) years; and

WHEREAS, upon the expiration of the current MOU, the parties wish to enter into a new Memorandum of Understanding for another six (6) year term;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Manager is hereby authorized to execute a Memorandum of Understanding with the Florida Department of Highway Safety and Motor Vehicles, for

governmental entity access to the Driver and Vehicle Information Database system, on behalf of the City of Fort Lauderdale.

SECTION 2. That the City Manager is authorized to execute any and all documents necessary or incidental to the Memorandum of Understanding.

SECTION 3. That the City Manager and his qualified designee are authorized to execute the Attestation Statements and Quarterly Quality Control Review Reports incidental to the Memorandum of Understanding.


SECTION 4. That the office of the City Attorney shall review and approve as to form all documents prior to their execution by the City Manager and the City Manager's qualified designee.

SECTION 5. That the effective date of this Resolution is the date of adoption.


