Scope of Work

Approach: Fort Hill will perform a review of PCI 275 to help safeguard the City's interests by identifying whether the impact truly warrants the cost and time extensions. Fort Hill will perform the following activities for this PCI:

- 1. Initial Review of the PCI: Understand the Construction Manager's stated impacts and determine which activities were affected.
 - Review PCI details to identify the activities or tasks referenced.
 - Identify any referenced key milestones and verify existence of sufficient documentation, such as backup data.
 - Review Exhibit E CPM network logic to identify "deflection remediation" tasks on the critical path and perform float analysis to confirm no hidden float.
- 2. Map the PCI to Project Schedule: Determine how the impact mentioned in the PCI aligned with the project's baseline, recovery, and current schedules.
 - Map the PCI from the notice to the Baseline Schedule (original contractual schedule).
 - Compare these activities with the Recovery Schedule (if any), to identify any recovery strategies applied.
 - Cross-reference the activities with the Latest Updated Schedule to capture the current status of the PCI activities.
 - Identify overlapping delays (e.g., asbestos abatement, equipment relocation) and evaluate if work was sequenced to mitigate impact
- 3. Analyze Schedule Float and Critical Path Status: Determine whether the PCI had float available and whether it fell on the project's critical path.
 - Evaluate the float available for the PCI using the project scheduling software.
 - Identify any free float and determine whether enough float was available to absorb the delay without impacting the overall project timeline.
 - Critical Path Identification: Verify whether the activities were on the critical path.
- Perform Cost Analysis: Review average monthly GC burn against cost ledgers
 - Compare projected cost to job cost accruals
 - Review timecards and cost reports to validate spend
 - Recalculate GR cost for the impacted months.
 - Verify insurance and bond fee calculations on the GC/GR and compliance with contract fee caps or markup limits.

- 5. Reporting: Draft Findings & Recommendations Report and Summarize float and concurrency impacts including the cost of delays and number of delay days related to deflection.

Deliverables: Provide recommendations to the city summarizing the PCI analysis of float and critical path. Each response will be supported by documented schedule analysis, impact calculations, and any necessary contractual references.

Timeline: Fort Hill expects to complete the above scope in four to six weeks following notice-to-proceed (provided no participation in any Moss 'workshops').
