

RESOLUTION NO. 25-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA, ADOPTING AND APPROVING A TENTATIVE BUDGET OF THE SUNRISE KEY NEIGHBORHOOD IMPROVEMENT DISTRICT FOR FISCAL YEAR BEGINNING OCTOBER 1, 2025, AND ENDING SEPTEMBER 30, 2026.

WHEREAS, pursuant to applicable provisions of law, the Board of Directors for the Sunrise Key Neighborhood Improvement District has prepared a tentative budget of the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2025, and ending September 30, 2026; and

WHEREAS, a "Notice of Public Hearings on the Proposed Millage Rates and Tentative Budgets for ... the Sunrise Key Neighborhood Improvement District for the Fiscal Year Beginning October 1, 2025, and Ending September 30, 2026," has been published as required in Section 200.065, Florida Statutes, advising the public that a public hearing on the proposed millage rate and tentative budget would be held on September 3, 2025, at 5:01 P.M., or as soon thereafter as possible, before the City Commission at the Broward Center for the Performing Arts, Mary N. Porter Riverview Ballroom, 201 SW 5th Avenue, Fort Lauderdale, Florida; and

WHEREAS, said public hearing has been held as stated above and comments from the public, if any, concerning said proposed millage rate and tentative budget have been heard and considered; and

WHEREAS, the Sunrise Key Neighborhood Improvement District set its millage rate at 1.0000 mill and established its budget of \$199,800 at its May 6, 2025, meeting, and the revenue generated from this millage rate is estimated at \$223,168; and

WHEREAS, it is the desire of the City Commission of the City of Fort Lauderdale to adopt a tentative budget of the Sunrise Key Neighborhood Improvement District for the fiscal year beginning October 1, 2025, and ending September 30, 2026;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the budget set forth in Exhibit 1 to Commission Agenda Memo #25-0703 is hereby adopted and approved as the tentative budget of the Sunrise Key Neighborhood Improvement District for the fiscal period beginning October 1, 2025, and ending September 30, 2026, and is incorporated herein by this reference.

SECTION 2. That a public hearing to adopt a final budget shall be held in accordance with Section 200.065, Florida Statutes.

SECTION 3. That this resolution will take effect immediately upon its adoption.
