TITLE: Motion to approve the purchase of a 2014 Aquatech B-15 sewer cleaner body – Florida Sheriff’s Association contract 13-11-0904 - \$220,875.17

Recommendation

It is recommended that the City Commission approve the purchase of a 2014 Aquatech B-15 sewer cleaner body, using the Florida Sheriff’s Association contract 13-11-0904 from Pat’s Pump & Blower, L.L.C., in the amount of \$220,875.17 contingent upon City Commission approval of Commission Memo #14-0172 for a 2014 International Workstar truck.

Background

Unit V5495 is a 2005 Freightliner chassis with a Vactor sewer cleaner body used to clean the gravity sewer collection systems throughout the City of Fort Lauderdale. This vehicle was scheduled to be replaced in December 2011. Unit V5495 has been removed from service due to extensive corrosion. This Aquatech B-15 sewer cleaner body will be mounted on the 2014 International Workstar listed on CAM # 14-0172.

Resource Impact

There will be a fiscal impact to the City in the amount of \$220,875.17.
