TITLE: **REVISED CP-8** - Motion Approving a First Amendment to Service Agreement for Summer Food Service Program Provider to Increase Annual Contract Amount – All Kids Catering, Inc. - \$33,831-
(Commission Districts 1, 2, 3 and 4)

Recommendation

Staff recommends the City Commission approve a First Amendment to Service Agreement for Summer Food Service Program Provider, in substantially the form attached, to increase the current annual contract compensation amount of \$70,638.75 by an additional annual compensation amount of \$33,831, for a combined total annual compensation amount of \$104,469.75, and a potential total contract in the amount of \$417,879 should the City and Contractor exercise all renewal options, and authorize the City Manager to execute this Agreement and all documents necessary and incidental thereto.

Background

The Parks & **and** Recreation Department uses this contract to provide summer lunches and snacks for its' summer camp programs. The food provided for the program this year was extremely well received by program participants resulting in more children participating in the program and receiving meals. In addition, the original costs were based off reduced COVID-19 registrations, however, once the summer camp programs returned to normal registration numbers it caused a shortfall. This in-turn increased the food orders and the overall projected amount of money allocated for the program.

On March 30, 2023, the Procurement Services Division issued an Invitation to Bid (Event No. 73) for a summer food service program provider. The solicitation ended on April 17, 2023, with a total of five (5) bids submitted.

All Kids Catering, Inc met the requirements of the bid and was deemed the lowest, responsive, and responsible bidder for the non-Agenda award. The initial term of the contract is June 1, 2023, through May 31, 2024.
