

RESOLUTION NO. 24-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING AND AUTHORIZING EXECUTION OF AMENDMENT NUMBER ONE (1) TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, DISTRICT FOUR (4) MAINTENANCE MEMORANDUM OF AGREEMENT FOR THE MAINTENANCE OF RECTANGULAR RAPID FLASHING BEACONS ON STATE ROAD A1A AT SEBASTIAN STREET AND ALHAMBRA STREET; PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on June 3, 2015, the City of Fort Lauderdale, Florida ("City") entered into a District Four Maintenance Memorandum of Agreement ("MMOA") with the Florida Department of Transportation ("FDOT") for the maintenance of In-Roadway Warning Lights, within the right-of-way of State Road A1A, within the corporate limits of the City; and

WHEREAS, the In-Roadway Warning Lights were installed, at the request of the City, to improve visibility for pedestrians to cross at unsignalized intersections, in accordance with the plans and specifications of the MMOA; and

WHEREAS, subsequently, Rectangular Rapid Flashing Beacons (RRFBs) were installed by FDOT at an existing crosswalk on Alhambra Street, at Mile Post 0.033 and at an existing crosswalk on Sebastian Street, at Mile Post 2.391, within the original project limits along State Road A1A between Mile Post 1.501 and Mile Post 3.320 (project limits); and

WHEREAS, installation of the RRFBs did not extend the City's maintenance limits pursuant to the original MMOA; and

WHEREAS, FDOT requires the City to enter into Amendment Number One (1) to the MMOA, to increase the City's maintenance responsibilities within the project limits along State Road A1A;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission of the City of Fort Lauderdale, Florida, hereby approves and authorizes execution of Amendment Number One (1) to the State of Florida Department of Transportation, District Four (4) Maintenance Memorandum of Agreement for the

Maintenance of Rectangular Rapid Flashing Beacons on State Road A1A, at Sebastian Street and Alhambra Street.

SECTION 2. That the Office of the City Attorney shall review and approve as to form all documents prior to their execution by the City Manager or their designee.

SECTION 3. That all resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4. That if any clause, section, or other part of this Resolution shall be held by any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional or invalid part shall be considered as eliminated and in no way affecting the validity of the other provisions of this Resolution.

SECTION 5. That this Resolution shall be in full force and effect upon its adoption.
