**TITLE:** Second Reading – Ordinance Amending the City of Fort Lauderdale Code of Ordinances Section 5-28, Location of Establishments Permitting Partial Nudity, and Nudity and Section 5-28.1, Nudity Sexual Conduct Prohibited, to Update Requirements for Alcohol Consumption for Hotel Use – Case No. UDP-T25003 - (**Commission Districts 1, 2, 3 and 4**)

**Recommendation**

Staff recommends the City Commission consider an ordinance amending the City's Code of Ordinances Section 5-28 Location of Establishments Permitting Partial Nudity and Section 5-28.1. – Nudity, sexual conduct prohibited, to exempt clothing optional hotels for certain requirements.

**Background**

The Code of Ordinance contains regulations for alcoholic beverage establishments permitting partial nudity that address the location of such establishments and conduct within those establishments. The original purpose of adopting these regulations was to control the effects of these types of businesses have on adjacent properties, prevent unlawful and unhealthy sexual activities, address legitimate health concerns regarding sexually transmitted diseases, and prevent sexual contact between patrons and employees. The regulations are effective but also impacted other establishments that permit nudity in a non-sexual context.

Nudists and naturists practice non-sexual social nudity in places provided for or set apart for such purposes. The existing code language prevents facilitates that cater to nudists and naturist clients from serving those clients alcoholic beverages. The proposed amendment would not require an alcoholic beverage establishment that is an accessory or ancillary use to a clothing optional hotel, a hotel as defined in the UDLR that contains 200 or more sleeping rooms and permits partial nudity on premises within access-controlled areas, to be subject to the limitations of distance separation and certain conduct restrictions provided the establishment meets the following criteria:

- The entire property of the hotel is fully enclosed and gated to the extent permissible by and in compliance with the City Fort Lauderdale, Florida, Unified Land Development Regulations; and

- Access to the hotel is only granted to patrons and guests of the hotel whose reservation and age are verified by security; and
- The hotel contains an on-site food establishment for guests; and
- Hotel staff are fully clothed at all times; and
- Adults 21 years and older are the only patrons and guests permitted on the premises of the hotel; and
- Partial nudity is only permitted at the pool areas that are fully enclosed and has controlled access; and
- Any alcohol sold may only be sold or served from a fully enclosed bar area located in the pool area; and
- No person outside the hotel facility will be able to observe any nudity or partial nudity of any hotel patron or guest; and
- The hotel must require each hotel guest or patron to sign a waiver acknowledging that they have been advised that the hotel allows nudity at its pools. Such waiver is a prerequisite for entry and any patron or guest that refuses to sign the waiver shall immediately be informed that they are not permitted on the hotel property. All waivers must be presented to the patron or guest in an area where there is no nudity and where nudity cannot be viewed.

The proposed ordinance is attached as Exhibit 1.
