- TITLE: Motion Approving an Agreement for Design Services for Fire Rescue Station No. 13 and Emergency Medical Substation No. 88 – H2M Architects & Engineers, Inc. - \$1,096,299.07 - (Commission Districts 2 and 4)

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, for Design Services for Fire Rescue Station No. 13 and Emergency Medical Substation No. 88 with H2M Architects & Engineers, Inc., in the amount not to exceed \$1,096,299.07.

Background

The City is seeking the services of a qualified firm to provide professional design services for a design criteria package for Fire Rescue Station No. 13 and Emergency Medical Substation No. 88. Fire Rescue Station No. 13 will be located at 2871 East Sunrise Boulevard and will meet the needs of the Fire Rescue Department pursuant to the Fire Rescue Construction Bond referendum, approved in November 2004. Emergency Medical Substation No. 88 will be located at 507 SE 11th Court. This additional Emergency Medical Substation is needed to provide additional emergency fire and medical services in the downtown area and in the areas along South Federal Highway.

On August 9, 2024, the Procurement Services Division issued a Request for Qualifications (RFQ) Event No. 352 for a consultant to provide Design Criteria Package services for Fire Rescue Station No. 13 and Emergency Medical Substation No. 88. The City received proposals from the following eight (8) firms in response to the solicitation, which closed on September 11, 2024.

Two (2) of the eight (8) firms identified as a Disadvantaged Business Enterprise. All firms were reviewed for compliance with the solicitation requirements and ranked based on the evaluation criteria shown in the table below and deemed responsive and responsible.

On October 16, 2024, the Evaluation Committee (Committee) evaluated all firms and shortlisted the following firms for further consideration:

- 1. Brunton Architects, LTD Inc
- 2. CPZ Architects, Inc
- 3. H2M Architects & Engineers, Inc.
- 4. Synalovski Romanik Saye, LLC

On November 4, 2024, the Committee convened and heard presentations from the four (4) shortlisted firms. After discussion and consideration, the Committee ranked H2M Architects & Engineers, Inc. as the highest ranked, responsive, and responsible firm. All negotiations have been successfully completed, and Staff is recommending H2M Architects & Engineers, Inc. for award consideration.

Resource Impact

There will be a fiscal impact to the City in the amount of \$1,096,299.07 for the design criteria package services agreement and \$327,168 for in-house project management fees for a total cost of \$1,423,467.07. Funds for this agreement, in the amount of \$1,423,467.07 are available in the FY 2025 Community Investment Plan in the accounts listed below.
