A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, REGARDING THE APPEAL OF THE CITY ENGINEER'S ACTION DENYING RIGHT-OF-WAY PERMITS, MAKING CERTAIN FINDINGS AND SETTING A PUBLIC HEARING TO CONSIDER THE APPEAL BEFORE THE CITY COMMISSION AT 6:00 P.M. ON NOVEMBER 4, 2014.

WHEREAS, pursuant to City Code Sec. 25-100.1, Crown Castle NG East, Inc., submitted Applications 13-01, 13-04, 13-05, 13-06, 13-07, 13-09, 13-11, and 13-12_for installation utility poles, ground mounted cabinets and Distributed Antenna Systems of twelve cabinets and utility poles; and

WHEREAS, on August 27, 2013, the City Engineer, through his designee, issued a letter formally denying the foregoing Applications for right-of-way permits; and

WHEREAS, pursuant to Section 25.100.2 of the City of Fort Lauderdale Code of Ordinances, the Applicant has appealed the decision of the City Engineer to the City Commission; and

WHEREAS, at its meeting of November 4, 2014, the City Commission reviewed the record and has found and determined that as to Applications 13-01, 13-04, 13-05, 13-06, 13-07, 13-09, 13-11, and 13-12 there was a departure from the essential requirements of law or that competent substantial evidence does not exist to support the decision of the City Engineer; and

WHEREAS, the City Commission will review the decision of the City Engineer denying the applications;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:
