Recommendation

Staff recommends the City Commission authorize payment of attorney fees and non-taxable costs in *Fort Lauderdale Food Not Bombs, et al., v. City of Fort Lauderdale*, Case No. 15-60185-civ-AMC, United States Court of Appeals for the Eleventh Circuit No. 23-10173, by paying the amount of \$638,196 to plaintiffs' attorneys Law Offices of Mara Shlackman, P.L., and Southern Legal Counsel, Inc., to satisfy the award of attorneys' fees, non-taxable costs, and interest.

Background

The City was sued in the United States District Court for the Southern District of Florida by Fort Lauderdale Food Not Bombs and four other plaintiffs related to enforcement of a City Ordinance on social services and food distribution from November 2014. The District Court awarded attorney's fees and non-taxable costs to the Plaintiffs in the amount of \$603,039 in December 2022, which the Plaintiffs appealed to the United States Court of Appeals for the Eleventh Circuit.

The Court of Appeals issued a Mandate confirming the award of attorneys' fees and non-taxable costs in the amount of \$603,039, and interest from December 2022 at a rate of 5.38% per annum for a total of \$638,196. Based upon the Mandate, defense counsel recommends that the City issue payment to satisfy the award of attorneys' fees, non-taxable costs, and interest.

Resource Impact

There will be a fiscal impact to the City in the amount of \$638,196.
