## Recommendation

It is recommended that the City Commission approve a purchase of 11 2014 Braun Super Chief Type I Medium Duty Ambulances via the Florida Sheriff's Association Contract 11-10-1202 from Ten-8 Fire Equipment, Inc., in the amount of \$3,051,569.84, and approve and authorize execution of the addendum to any contract between the City of Fort Lauderdale and Ten-8 Fire Equipment, Inc., for the purchase of fire rescue vehicles, in substantially the form attached.

## **Background**

The Fort Lauderdale Fire-Rescue Department is in need of replacement rescue apparatus to properly respond to medical and fire related emergencies to safe guard the City's neighbors and guests. The rescue vehicles are specified to meet operational requirements and standardization to properly carry required medical and fire related gear, equipment, and supplies for the various types of services that are provided. These services include Basic Life Support (BLS)/Advanced Life Support (ALS) medical calls, trauma-related calls, fire and specialty-related calls that can include marine, Technical Rescue Team (TRT), and Hazardous Materials (HazMat) operations. In addition, the rescue vehicles are designed and specified with gear and equipment to properly perform inter-facility transports (IFT's) that are revenue generating for the City of Fort Lauderdale.

Pursuant to Section 2-181(8) of the Code of Ordinances, this purchase will be made in accordance with Florida Sheriff's Association Contract 11-10-1202 from Ten-8 Fire Equipment, Inc., in the amount of \$3,051,569.84, whereby such contract was entered into following a fair and competitive process that included public notice, sealed written or secure electronic bids and public bid opening.

## ADDENDUM TO ANY CONTRACT BETWEEN CITY OF FORT LAUDERDALE AND TEN-8 FIRE EQUIPMENT, INC., FOR THE PURCHASE OF FIRE RESCUE VEHICLES

WHEREAS, the City of Fort Lauderdale, a Florida municipality, ("City"), is purchasing fire rescue vehicles *via* the Florida Sheriff's Association Contract 11-10-1202 with Ten-8 Fire Equipment, Inc., a Florida corporation, ("Florida Sheriff's Association Contract"),

NOW THEREFORE, as an addendum to any contract whereby the City purchases fire rescue vehicles from Ten-8 Fire Equipment, Inc., *via* the Florida Sheriff's Association Contract, the City and Ten-8 Fire Equipment, Inc., agree as follows:

Subject to Odebrecht Construction, Inc., v. Prasad, 876 F.Supp.2d 1305 (S.D. Fla. 2012), affirmed, Odebrecht Construction, Inc., v. Secretary, Florida Department of Transportation, 715 F.3d 1268 (11th Cir. 2013):

Ten-8 Fire Equipment, Inc., certifies that it is not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List and that it does not have business operations in Cuba or Syria as provided in section 287.135, Florida Statutes (2013), as may be amended or revised. The City may terminate any contract to purchase fire rescue vehicles at the City's option if Ten-8 Fire Equipment, Inc., is found to have submitted a false certification as provided under subsection (5) of section 287.135, Florida Statutes (2013), as may be amended or revised, or been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or has been engaged in business operations in Cuba or Syria, as defined in Section 287.135, Florida Statutes (2013), as may be amended or revised.

WHEREFORE, the City and Ten-8 Fire Equipment, Inc., execute this Addendum to any Contract between City of Fort Lauderdale and Ten-8 Fire Equipment, Inc., for the Purchase of Fire Rescue Vehicles as follows:
