

**FIRST AMENDMENT TO THE
FY 2015 NOT FOR PROFIT GRANT PARTICIPATION AGREEMENT WITH
WINTERFEST, INC.**

THIS FIRST AMENDMENT TO THE AGREEMENT, entered this _____ day of _____ 2015 by
and between:

CITY OF FORT LAUDERDALE, a municipal corporation of the State of
Florida, herein after referred to as "City"

and

WINTERFEST, INC., a non-profit corporation organized under the laws of
Florida whose usual place of business is 512 NE 3rd AVENUE, FORT
LAUDERDALE, FL 33301, hereinafter referred to as "Participant".

WHEREAS, on or about December 16, 2014, the City and Participant entered into a participation
agreement for the Annual Winterfest Boat Parade and to build a festival and full complement of events
around the Greater Fort Lauderdale Area; and

WHEREAS, during the Winterfest Boat Parade and festival planning sessions, additional safety
measures, such as Police presence have been included to ensure a safe and secure environment; and

WHEREAS, it is estimated that these additional security costs will be approximately \$2,778.50; and

WHEREAS, the City is desirous to provide funding for Participant's program; and

NOW, THEREFORE, it is agreed between the parties hereto that the Participation Agreement is amended
as follows:

SECTION 1 – Additional police presence will be provided to ensure a safe and secure environment
is required.

SECTION 2 – The City agrees to reimburse the additional related security costs in an amount not to
exceed \$2,778.50.

SECTION 3 - It is agreed between the parties hereto that except as modified herein, all remaining
terms and conditions of the Agreement shall remain in full force and effect.
