Order

Recommendation

It is recommended that the City Commission approve Task Order No. 2 (Exhibit 1) with Calvin, Giordano & Associates, Inc., in the amount of \$171,606 for design, permitting, bidding, and construction services for the Pump Station B-10 Rehabilitation (Exhibit 2) located at Imperial Point Drive and Northeast 21st Lane.

Background

Pump Station B-10 was constructed in the early 1960's, and serves a large sewer basin area that includes the Imperial Point Hospital. The station has provided decades of service and is in need of major repairs. This project will completely restore the facility, extend its life, and upgrade the wastewater infrastructure in the Imperial Point Neighborhood. The work includes the removal and replacement of all equipment, such as pumps, pipes, valves, fittings, electrical and mechanical equipment, electrical lighting, hatches, ladders, grates, landscaping, and painting.

This task order is being entered into pursuant to the Continuing Contract for Civil Engineering Consultant Services Agreement (Contract 626-10881) with Calvin, Giordano & Associates, Inc., in accordance with the terms of the agreement for professional services dated November 6, 2012 (CAR# 12-2299) and renewed on October 21, 2014 (CAM 14-1066). Task Order No. 2 is being performed under the terms and conditions of the Amended Master Agreement.

Resource Impact

There will be a fiscal impact to the City in the amount of \$171,606 for the task order and \$20,593 for in house project management fees, for a total of \$192,199.
