BACKGROUND/DETAIL:

Broward County has received a Broward Boulevard Livable Mobility Grant for landscaping along Broward Boulevard for beautification and to improve the comfort of the traveling public.

As part of the agreement, Broward County will install, at its cost, landscaping with the required permitting in the right-of-way along Broward Boulevard from Andrews Avenue to State Road 7. Estimated cost of the landscaping is \$186,243 and the proposed landscaping listing is included as part of the agreement in Exhibit 1. Broward County estimates the landscaping to be installed between June and September 2013.

This landscaping project will coincide with the Broward Boulevard Gateway Project that is also on the July 10, 2012 agenda (CAR 12-0981) in which the City has partnered with other agencies to improve mobility, accessibility, connectivity, and quality of life along Broward Boulevard, with the goal of creating a gateway to downtown.

In addition, the City's Parks & Recreation Department is currently maintaining the area with a contractor and existing city staff so there is no budget impact.

Staff recommends that the City Commission approve the Landscaping Installation and Maintenance Agreement with Broward County.
